Abstract: Increases the driver's license fee by one dollar to benefit the La. Military Family Assistance Fund.

Present law provides for a class "D" driver's license fee of \$42.75, except for residents of the city of New Orleans. Present law further provides for the distribution of the fee according to present law.

Proposed law increases the class "D" driver's license fee from \$42.75 to \$43.75, except for residents of the city of New Orleans. Proposed law further provides for the distribution of the additional \$1.00 to the La. Military Family Assistance Fund (fund).

Present law provides for a class "D" driver's license fee of \$54.00 for residents of the city of New Orleans. Present law further provides for the distribution of the fee according to present law.

Proposed law increases the class "D" driver's license fee from \$54.00 to \$55.00 for residents of the city of New Orleans. Proposed law further provides for the distribution of the additional \$1.00 to the fund.

Present law provides for a class "E" driver's license fee of \$20.25, except for residents of the city of New Orleans. Present law further provides for the distribution of the fee according to present law.

Proposed law increases the class "E" driver's license fee from \$20.25 to \$21.25, except for residents of the city of New Orleans. Proposed law further provides for the distribution of the additional \$1.00 to the fund.

Present law provides for a class "E" driver's license fee of \$20.25 for residents of the city of New Orleans. Present law further provides for the distribution of the fee according to present law.

Proposed law increases the class "E" driver's license fee from \$20.25 to \$21.25 for residents of the city of New Orleans. Proposed law further provides for the distribution of the additional \$1.00 to the fund.

Present law provides for a class "A", "B", or "C" commercial driver's license fee of \$61.50, except for residents of the city of New Orleans. Present law further provides for the distribution of the fee according to present law.

Proposed law increases the class "A", "B", or "C" commercial driver's license fee from \$61.50 to

\$62.50, except for residents of the city of New Orleans. Proposed law further provides for the distribution of the additional \$1.00 to the fund.

Present law provides for a class "A", "B", or "C" commercial driver's license fee of \$76.50 for residents of the city of New Orleans. Present law further provides for the distribution of the fee according to present law.

Proposed law increases the class "A", "B", or "C" commercial driver's license fee from \$76.50 to \$77.50 for residents of the city of New Orleans. Proposed law further provides for the distribution of the additional \$1.00 to the fund.

Present law provides for applicants 70 years or older a class "E" driver's license fee of \$6.75, except for residents of the city of New Orleans. Present law further provides for the distribution of the fee according to present law.

Proposed law increases the fee for applicants 70 years or older for a class "E" driver's license from \$6.75 to \$7.75, except for residents of the city of New Orleans. Proposed law further provides for the distribution of the additional \$1.00 to the fund.

Present law provides for applicants 70 years or older a class "D" driver's license fee of \$22.13, except for residents of the city of New Orleans. Present law further provides for the distribution of the fee according to present law.

Proposed law increases the fee for applicants 70 years or older for a class "D" driver's license from \$22.13 to \$23.13, except for residents of the city of New Orleans. Proposed law further provides for the distribution of the additional \$1.00 to the fund.

Present law provides for applicants 70 years or older, and a resident of the city of New Orleans, a class "E" driver's license fee of \$6.75. Present law further provides for the distribution of the fee according to present law.

Proposed law increases the fee for applicants 70 years or older, and a resident of the city of New Orleans, for a class "E" driver's license from \$6.75 to \$7.75. Proposed law further provides for the distribution of the additional \$1.00 to the fund.

Present law provides for applicants 70 years or older, and a resident of the city of New Orleans, a class "D" driver's license fee of \$27.75. Present law further provides for the distribution of the fee according to present law.

Proposed law increases the fee for applicants 70 years or older, and a resident of the city of New Orleans, for a class "D" driver's license from \$27.75 to \$28.75. Proposed law further provides for the distribution of the additional \$1.00 to the fund.

Present law provides for funds received pursuant to present law to be deposited to the La. Military Family Assistance Fund.

Proposed law adds the revenue derived from proposed law to the funds deposited in the La. Military Family Assistance Fund.
