2 To amend and reenact R.S. 37:2175.1(A)(1) and 2175.3(A)(9), to enact R.S. 37:2171.3, and 3 to repeal R.S. 37:2175.3(A)(11), relative to contractors; to require the provision of 4 name, license, classification, and insurance information to certain persons; to provide 5 for penalties; to require certain information be included in home improvement 6 contracting agreements; to provide for prohibited acts; and to provide for related 7 matters. 8 Be it enacted by the Legislature of Louisiana: 9 Section 1. Abstract: Requires contractors to provide the contractor's license or registration number, classification, and evidence of insurance to the contracting party for whom the work is to be performed.

<u>Proposed law provides</u> that any person required to be licensed or registered pursuant to <u>present law</u> (R.S. 37:2167 and 2175.2) shall provide, in writing, to the party with whom he has contracted to perform contracting services his name, contracting license number, classification, and current insurance certificates evidencing the amount of workers' compensation and liability insurance maintained, regardless of whether such information is requested by the contracting party for whom the work is to be performed.

<u>Proposed law</u> further provides that failure of the person required to be licensed or registered to comply with <u>proposed law</u> shall be deemed a willful failure to comply with <u>present law</u> (R.S. 37:2158(A)(3)).

<u>Proposed law provides</u> that any person required to be licensed or registered pursuant to <u>present law (R.S. 37:2167 and 2175.2)</u> shall produce to the appropriate permitting authority evidence of a license or registration in good standing prior to the issuance of any permit required by law.

<u>Present law</u> provides that every agreement to perform home improvement contracting services, as defined by <u>present law</u>, in an amount in excess of \$1,500, but not in excess of \$75,000, shall be in writing and shall include the documents and information as required by <u>present law</u>. Further, <u>present law</u> requires, in pertinent part, that such an agreement to perform home improvement contracting services must include the complete agreement between the owner and the person required to be licensed or registered and a clear description of any other documents which are or shall be incorporated into the agreement. <u>Proposed law</u> further requires such an agreement to include current insurance certificates evidencing the amount of workers' compensation and liability insurance maintained by the person required to be licensed or registered.

<u>Present law</u> establishes an enumerated list of acts that are prohibited for any persons performing home improvement contracting services. <u>Proposed law</u> deletes a provision of <u>present law</u> requiring persons performing home improvement contracting services to possess any insurance as required by federal law. <u>Proposed law</u> makes it a prohibited act for any persons performing home improvement contracting services to fail to provide, in writing to the party with whom he has contracted to perform contracting services, his name, registration number, and current insurance certificates evidencing the amount of workers' compensation and liability insurance maintained, regardless of whether such information is requested by the contracting party for whom the work is to be performed.

<u>Proposed law</u> repeals a provision of <u>present law</u> requiring any persons performing home improvement contracting services to obtain any insurance required by federal law.
