However, if the police employee or law enforcement officer is confined to a medical facility due to injury or illness related 28 to the officer-involved incident, or if two or more police employees or law 29 enforcement officers are involved in the officer-involved incident, the police 30 employees or law enforcement officers shall be granted up to thirty days to secure 31
- 32 representation.

1	(iii) For purposes of this Subparagraph, "officer-involved incident" means
2	any incident in which serious bodily injury or death of another individual is caused
3	by any intentional or accidental use of a dangerous or deadly weapon by a police
4	employee or law enforcement officer which results from the efforts of a police
5	employee or law enforcement officer attempting to effectively arrest or otherwise
6	gain control of another or while in police custody.
7	(iv) For purposes of this Subparagraph, "serious bodily injury" means bodily
8	injury which involves unconsciousness, extreme physical pain or protracted or
9	obvious disfigurement, or protracted loss or impairment of a bodily member, organ,
10	or mental faculty, or a substantial risk of death."
