5 civil penalties; to provide relative to the distribution of funds collected as civil penalties; to"

7 On page 2, line 5, after "and" and before "Enforcement" change "Custom" to "Customs"

8 AMENDMENT NO. 4

9 On page 2, line 17, after "any" delete the remainder of the line and insert "person under
10 lawful arrest or"

11 AMENDMENT NO. 5

12 On page 3, line 6, after "recovers" and before "received" delete "all monies" and insert "any
13 state grant funds or general appropriation funds"

14 AMENDMENT NO. 6

15 On page 3, line 10, after "police," delete the remainder of the line and insert "governing
16 authority of a political"

17 AMENDMENT NO. 7

18 On page 3, line 11, after "powers" delete the remainder of the line, insert a comma "," and

4 On page 4, at the beginning of line 22, delete "violation" and insert "unlawful sanctuary
5 policy to the state agency or political subdivision named in the order and"

6 AMENDMENT NO. 13

7 On page 4, at the beginning of line 25, change "B." to "B.(1)"

8 AMENDMENT NO. 14

9 On page 5, between lines 2 and 3, insert the following:

10 "(2) All monies collected pursuant to the provisions of this Subsection shall be
11 distributed as follows:

12 (a) Fifty percent to the Crime Victims Reparations Fund.

13 (b) Fifty percent to Louisiana Public Defender Fund, established by R.S. 15:167."

14 AMENDMENT NO. 15

15 On page 5, after line 14, add the following:

16 "Section 2. R.S. 46:1816(B)(9) is hereby enacted to read as follows:

17 §1816. Crime Victims Reparations Fund; creation; sources and use of funds

19 B. The fund shall be composed of:
