Abstract: Increases the amount of an individual sewage fee imposed by the office of public health.

<u>Present law</u> provides that the department shall charge and collect a one-time fee of \$100 for each individual-type sewerage system installed for residential use.

Proposed law increases the fee from \$100 to \$150.

Effective upon signature of governor or lapse of time for gubernatorial action.

(Amends R.S. 40:31.32(B) and (E)(2))

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Health and Welfare</u> to the original bill:

- 1. Delete the following fee increases which had been provided in proposed law:
 - (a) An increase in the fee for each sewerage installer license <u>from</u> \$100 to \$150.
 - (b) An increase in the fee for each sewerage maintenance license <u>from</u> \$100 to \$150.
 - (c) An increase in the fee for each combination installer and maintenance license from \$100 to \$150.
 - (d) An increase in the fee for each sewerage treatment and interrelated systems inspection or related request associated with loanmaking procedures for existing residential and commercial properties <u>from</u> \$100 to \$150.
- 2. Make technical changes.
