AGRICULTURE/FOREST DEPT: Requests the Department of Agriculture and Forestry to study implementing a master logger certification program under the office of forestry

A CONCURRENT RESOLUTION

2	To urge and request the Department of Agriculture and Forestry to study the feasibility of
3	implementing a master logger certification program under the office of forestry in
4	the Department of Agriculture and Forestry to be administered by the Louisiana
5	Forestry Association.
6	WHEREAS, the primary responsibilities of the office of forestry are to: suppress
7	timberland wildfires; promote sound forest management practices; disseminate information;
8	facilitate educational programs; produce reforestation seedlings; enforce timber-related laws;
9	investigate timber theft; and assist community urban forestry programs; and
10	WHEREAS, Louisiana's forestlands cover forty-eight percent of the state's land area
11	or 13.8 million acres; and
12	WHEREAS, this renewable resource provides the raw material for Louisiana's
13	second largest manufacturing employer, the forest products industry, with over nine hundred
14	firms in forty-five parishes directly employing over twenty-five thousand people and an
15	additional eight thousand people are employed harvesting and transporting the resource; and
16	WHEREAS, with adequate protection, followed by appropriate and accepted forest
17	management techniques, Louisiana's forests are available to serve our state, both rural and
18	urban, not only on a sustained basis, but at an increased level of productivity; recognizing
19	the various interests and needs of so many owners, efforts to encourage and promote sound
20	forestry practices over such a vast area requires a balanced, educational process; and

1	WHEREAS, the Louisiana Forestry Association administers a Sustainable Forestry
2	Initiative (SFI) Master Logger program to certify loggers as master loggers; and
3	WHEREAS, the SFI master logger program will provide the tools needed to keep our
4	forests healthy and growing; and
5	WHEREAS, the program consists of a series of classes given over the span of two
6	days that an individual must attend in order to become certified as a Louisiana Master
7	Logger; and
8	WHEREAS, individuals are required to complete the core classes only once, but each
9	certified logger must earn a minimum of six continuing education credits each year in order
10	to maintain their certification; if a certified logger does not take the classes and is inactive
11	for three years, they must start the certification process over with the core classes; and
12	WHEREAS, implementing the program under the direction of the office of forestry
13	in the Department of Agriculture and Forestry allows the office of forestry to mandate that
14	all logging contractors and foremen receive master logger certification training; and
15	WHEREAS, the department supports the Louisiana Forestry Association
16	administering the program and the department believes that this program is a necessary and
17	important tool that the office of forestry can use to make sure that all loggers and foremen
18	are educated in the most up-to-date techniques to use when engaging in the harvest and
19	transport of timber.
20	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
21	urge and request the Department of Agriculture and Forestry to study the feasibility of
22	implementing a master logger certification program under the office of forestry in the
23	Department of Agriculture and Forestry to be administered by the Louisiana Forestry
24	Association.
25	BE IT FURTHER RESOLVED that the Department of Agriculture and Forestry
26	report its findings and recommendations to the Legislature of Louisiana on or before
27	February 1, 2018.
28	BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted
29	to the commissioner of the Department of Agriculture and Forestry and the Louisiana
30	Forestry Association.
