Amendments proposed by Representative Edmonds to Engrossed House Bill No. 518 by Representative Edmonds

1 AMENDMENT NO. 1

2 On page 1, line 2, between "R.S. 49:308.5(B)(3) and (4)" and the comma "," insert "and to  
3 enact R.S. 49:308.5(B)(5)"

4 AMENDMENT NO. 2

5 On page 1, line 7, after "reenacted" and before "to" insert "and R.S. 49:308.5(B)(5) is  
6 hereby enacted"

8 AMENDMENT NO. 3

9 On page 1, delete line 20 in its entirety and on page 2, line 1, delete "meeting of the Joint  
10 Legislative Committee on the Budget" and insert "no less than twenty-five percent of the  
11 special funds and dedications"

12 AMENDMENT NO. 4

13 On page 2, line 10, after "funds" and before "warrants" insert "and dedications"

14 AMENDMENT NO. 5

15 On page 2, between lines 11 and 12, insert the following:

16 "(4)(a) No later than fifteen days after the approval of the plan by the Joint  
17 Legislative Committee on the Budget, the committee shall cause to be posted on the  
18 website of the Louisiana Legislature, notification of a hearing schedule which shall  
19 include a date for presentation and discussion of each specified special fund in the  
20 approved plan. Additionally, the Joint Legislative Committee on the Budget shall  
21 notify the commissioner of administration and the treasurer of the hearing schedule.  
22 The commissioner of administration shall notify any agency or entity receiving an  
23 appropriation from a special fund specified in the plan in the previous five fiscal  
24 years of the hearing schedule.

25 (b)(i) No later than thirty days after the approval of the plan, the treasurer  
26 shall submit to the committee a summary of the terms, sources, conditions, and uses  
27 of the special fund as required by law and a five-year history of the following:

28 (aa) Sources and amounts of revenue into the fund.

29 (bb) Amounts appropriated or allocated from the fund and the recipients of  
30 each appropriation or allocation.

31 (cc) Investments and earnings on the fund.

32 (dd) Annual balance in the fund.

33 (ii) The treasurer or his staff shall be in attendance and available to provide  
34 information at any hearing that the committee holds on any special fund.

35 (c)(i) No later than thirty days after the approval of the plan, the head of each  
36 agency or entity receiving an appropriation or allocation from the special dedicated  
37 fund within the previous five years shall submit to the committee the following:

1           (aa) Five-year history of the amount of the appropriation or allocation of the  
2 fund to the agency or entity.

3           (bb) Detailed use of the fund in each of the previous five years in which the  
4 agency or entity received an appropriation or dedication from the fund, including the  
5 total amount of funding for each activity financed with the fund and the amount of  
6 financing for the activity from the fund.

7           (cc) Outcomes or other relevant performance information for any activity  
8 receiving financing from the fund.

9           (ii) The head of the agency or entity, or his staff, shall be in attendance and  
10 available to provide information at any hearing on a special fund received by their  
11 agency or entity.

12           (d) The committee shall allow public comment on each special fund included  
13 in the plan.

14           (e) The committee may request any other information which the committee  
15 believes is necessary in conducting the review of the special funds."

16 AMENDMENT NO. 6

17 On page 2, line 12, change "(4)(a)" to "(5)(a)"
