

1 WHEREAS, in 2002, Kim Sport served as the first-ever female chair of the United
2 Way's Regional Fundraising Campaign, and is one of only four women to have chaired the
3 Board of Trustees for the United Way of Southeast Louisiana; and

4 WHEREAS, Kim Sport served as the Katrina Recovery Chairman for the United
5 Way; in 2006, she chaired the "Seeing Is Believing" Conference in New Orleans; and in
6 2007, she delivered the keynote address – "Katrina: After the Cameras Leave" – at the
7 National Summit on Women and Philanthropy in San Antonio, Texas; and

8 WHEREAS, a three-time cancer survivor and career advocate, Kim Sport served as
9 the Local Survivor Chairman of the Susan G. Komen Breast Cancer Foundation's Race for
10 the Cure in 2003, and chaired the 2010 American Cancer Society Hope Gala, the 2011 Key
11 to the Cure Gala at Sak's Fifth Avenue, and the 2011 House of Pink event in cooperation
12 with the Louisiana Breast Cancer Task Force; and

13 WHEREAS, in 2010, Kim Sport launched "Breastoration", a philanthropic
14 partnership to assist and educate women contemplating surgical options following a
15 diagnosis of breast cancer; and

16 WHEREAS, Kim Sport collaborated with the Louisiana State Board of Medical
17 Examiners to draft the 2012 breast cancer treatment alternatives brochure which is mandated
18 by state law to be given by physicians to every woman diagnosed with breast cancer; and

19 WHEREAS, in 2013, Kim Sport was named to Ochsner's Women's Health Advisory
20 Board and co-chaired the patron party for Ochsner's Moonlight and Miracles Gala
21 benefitting cancer patients; and

22 WHEREAS, in 2013, Kim Sport became the first Public Policy Chairman of United
23 Way for Southeast Louisiana and during the 2014 Regular Session of the Legislature, she
24 led efforts to have domestic violence legislation introduced to help victims of domestic
25 abuse immediately divorce their abusers, provide punitive damages for physical and mental
26 injuries caused by family violence, increase criminal sanctions for domestic abuse and
27 violations of protective orders, and prohibit abusers from possessing a firearm for the
28 duration of a protective order issued against the abuser and for ten years after a conviction
29 for domestic abuse battery. All five bills passed unanimously and were signed into law by
30 Governor Jindal on May 29, 2014; and

1 WHEREAS, Kim Sport was elected to serve as the first chair of the Louisiana
2 Commission to Prevent Domestic Violence and has shepherded amendments to over fifty
3 provisions of domestic violence law; and

4 WHEREAS, for her tireless work advocating for victims of domestic abuse, Kim
5 Sport received a Distinguished Achievement Award from the Louisiana Coalition Against
6 Domestic Violence, was recognized as a Champion of the New Orleans Family Justice
7 Center, and was featured in "Five Awake", an award-winning documentary film that
8 chronicles her work on the historic 2014 legislative package to protect victims of domestic
9 abuse; and

10 WHEREAS, Kim Sport has been recognized for her many years of work as a
11 volunteer and advocate by being named the recipient of the National Society of Fundraising
12 Professionals' Outstanding Volunteer Fundraiser of the Year Award and the United Way of
13 Southeast Louisiana's Tocqueville Award, the United Way's highest award for exemplary
14 leadership in community, volunteerism, and philanthropy; and

15 WHEREAS, Kim Sport serves pro bono as an attorney and advisor in difficult
16 divorce cases involving family violence and conducts continuing education seminars to
17 family law and domestic violence professionals; and

18 WHEREAS, Kim Sport received the Louisiana State Bar Association Citizen Lawyer
19 Award in 2015, the Libby Milton Champion for Children Award in 2016, and was the first
20 Live United Award Individual honoree; and

21 WHEREAS, Kim Sport was named Louisiana Heroine by the Louisiana Association
22 of Nonprofit Organizations; Top Female Achiever by New Orleans Magazine; the 2000,
23 2004, and 2009 Woman of the Year by City Business Magazine; and City Business
24 Magazine Hall of Fame inductee; and

25 WHEREAS, she received the first statewide Woman of Excellence Award in the
26 category of Volunteerism and Civic Involvement from the Louisiana Legislative Women's
27 Caucus, and most recently, she received a Community Quarterback Award from the New
28 Orleans Saints organization.

29 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
30 commend Kim Sport of the United Way of Southeast Louisiana for her many

1 accomplishments, countless contributions, and tireless service to her community and the
2 state of Louisiana, and does hereby extend to her every good wish for success and happiness
3 in all of her future endeavors.
