Establishes a reinspection fee for facilities and establishments with sanitary code violations

<u>Proposed law</u> authorizes a \$150 re-inspection fee of any retail food establishments subject to regulation and inspection by the LA Department of Health (LDH), Office of Public Health (OPH). Under <u>proposed law</u>, the re-inspection fee will only be assessed on a second or subsequent re-inspection. The <u>proposed law</u> requires the owner of the commercial facility to pay the \$150 fee within 30-days. If not paid, <u>proposed law</u> allows OPH to revoke any permit held by the owner. Similar to existing law, <u>proposed law</u> allows owners to have an adjudicatory hearing before the Division of Administrative Law regarding revoking of a permit. <u>Proposed law</u> allows OPH not to issue any permit to an owner of an unpermitted facility until re-inspection fee is paid. <u>Proposed law</u> shall become effective on March 1, 2018.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

REVENUE EXPLANATION

The proposed legislation increases Fees and Self-Generated Revenues by \$13,800 in FY 18, and \$165,352 in future fiscal years within the LA Department of Health (LDH), Office of Public Health (OPH). The proposed legislation authorizes a new \$150 re-inspection fee on any retail food establishment under the regulation and inspection of OPH. The fee will be assessed only on second or subsequent re-inspections. Based on an average of 7,349 re-inspections completed on permitted food establishments annually, OPH anticipates that 15% or 1,102 will require a second or subsequent re-inspection and assessed a \$150 re-inspection fee (1,102 food establishments x \$150 re-inspection fee = \$165,352). This measure becomes effective on March 1, 2018. Therefore, in FY 18, revenues generated from re-inspection fees is anticipated at \$13,800 (92 food establishments for 4 months x \$150 re-inspection fee).
