HOUSE RESOLUTION NO. 154

BY REPRESENTATIVE BACALA

BUDGETARY PROCEDURES: Directs executive branch agencies receiving appropriations to prepare a report detailing the amount and impact of cuts to the agency's budget in FY 2016-2017

A RESOLUTION

2	To direct every state agency that receives an appropriation in the General Appropriation Act
3	and the Ancillary Appropriation Act to prepare a report detailing the amount and
4	impact of cuts to the agency's budget in the 2016-2017 Fiscal Year and to submit that
5	report to the House Committee on Appropriations no later than September 30, 2017.
6	WHEREAS, in Fiscal Year 2016-2017 there were two mid-year deficits totaling
7	\$616.8 million; and
8	WHEREAS, the first mid-year deficit for Fiscal Year 2016-2017, identified in
9	December 2016, was due to a year-end deficit for Fiscal Year 2015-2016 of \$312.6 million;
10	and
11	WHEREAS, a second mid-year deficit of \$304.2 million was identified in January
12	of 2017 due to a shortfall in projected revenue, and was eliminated through a combination
13	of reductions, transfers, and the use of \$99 million out of the Budget Stabilization Fund; and
14	WHEREAS, in the last nine years, there have been fifteen mid-year deficits because
15	of reductions in the official forecast of the Revenue Estimating Conference or because year-
16	end collections were below the amount forecasted, including two mid-year deficits per year
17	for the last three fiscal years; and
18	WHEREAS, the fifteen deficits averaged approximately \$240 million and have been
19	as high as \$570 million, with deficits in the current fiscal year totaling \$616.8 million; and
20	WHEREAS, the Five-year Base Line Projection for the State General Fund shows
21	projected expenditures exceeding projected revenues by \$403 million for Fiscal Year 2017-

1 2018, \$1.5 billion for Fiscal Year 2018-2019, and \$1.7 billion for Fiscal Year 2019-2020;

- 3 WHEREAS, members of the House Appropriations Committee have requested state
- 4 agencies to implement long-range reductions as an alternative to requiring additional state
- 5 revenues to address both current and prospective shortfalls.
- THEREFORE, BE IT RESOLVED that the House of Representatives of the
- 7 Legislature of Louisiana does hereby direct every state agency that receives an appropriation
- 8 in the General Appropriation Act and the Ancillary Appropriation Act to prepare a report
- 9 detailing the amount and impact of cuts to the agency's budget in the 2016-2017 Fiscal Year
- and to submit that report to the House Committee on Appropriations no later than September
- 11 30, 2017.
- BE IT FURTHER RESOLVED that the reports shall be submitted in the form and
- manner developed by the commissioner of administration and approved by the House
- 14 Committee on Appropriations, and shall include but not be limited to the following
- 15 information:
- 16 (1) Spreadsheets of expenditures for each program, by major expenditure category, and
- means of finance comparing the following:
- 18 (a) The amounts appropriated to the agency in Fiscal Year 2016-2017 as
- indicated by the appropriation letter provided to the agency by the
- 20 commissioner of administration.
- 21 (b) A listing of all increases or reductions, including all mid-year adjustments.
- 22 (c) The actual amounts expended as of September 1, 2017, by the agency at the
- 23 end of Fiscal Year 2016-2017.
- 24 (2) A narrative report detailing the impact of the Fiscal Year 2016-2017 mid-year
- reductions, and other budget changes during the year, including but not limited to the
- 26 following:
- 27 (a) The total change in spending.
- 28 (b) Programs and activities that were established or created.
- 29 (c) Programs and activities that were reduced or eliminated.

(c) 16 (d) The number of authorized and other charges positions filled and vacant by 17 month. 18 (e) The average number of full-time equivalent positions per month. 19 The number of authorized positions and authorized other positions vacant for (f) 20 all or part of Fiscal Year 2016-2017.

Bacala

Directs every state agency that receives an appropriation in the General Appropriation Act or Ancillary Appropriation Act to prepare a report detailing the amount and impact of cuts to the agency's budget in FY 2016-2017.

Requires the commissioner of administration to develop the form and manner of submission of the reports, subject to approval of the House Committee on Appropriations.

Provides for specific information to be included on spreadsheets, a narrative report, and a report on employees and vacancies. Requires the information to be submitted to the House Committee on Appropriations no later than Sept. 30, 2017.
