(k) Open-end mutual funds, closed-end mutual funds, exchange traded funds, 21 22 and unit investment trusts, and separately managed accounts consisting solely of 23 international securities constructed to match or track the components of a market index provided by globally recognized index providers, including but not limited to 24 25 MSCI, FTSE, Dow Jones, Standard & Poor's, Barclays, Citigroup, or any of their 26 affiliates or successors and assigns; however, the total investment in any and all such 27 index funds at any one time shall not exceed ten percent of the market value of all 28 funds held by the treasurer in the Louisiana Education Quality Trust Fund. Nothing 29 in this Subparagraph shall be construed to allow the state treasurer to invest directly 30 in the common stock of foreign companies known to do business with nations that 31 support terrorism.
