EXPENDITURE EXPLANATION

There will be no costs in order to implement the proposed legislation. The proposed legislation would not require the school to make changes to the logo, insignia, licensed or branded merchandise, promotional and fund raising items, or other related items or products, including class rings.

However, if the board members of the Louisiana School for Math, Science, and the Arts choose to make changes to the above items, there may be associated costs. LSMSA estimated costs of \$188,585 in order to rename the school. These costs include estimates for: Letterhead/Envelopes (\$2,500), Purchase Order Reprint (\$1,500), Front Exterior Sign (\$2,000), Building / Exterior / Parking Signs (\$5,480), Gonfalons/Flags (\$4,800), Vehicle Decals (\$775), Identification Card/Name Tag Reprinting (\$2,750), Business Cards (\$1,760), Recruitment Banners, Brochures and Promotional Items (\$7,620), Website Redesign (\$500), Consortium and University Documentation (\$250), License Plate Redesign (\$3,500), Copyrighting (\$2,500), Transcript/diploma/matriculation Template Redesign (\$500), Class Ring Redesign (\$500), Internal Signage (\$650), as well as the redesigning of the logo/school crest (\$1,000) which will be used on the supplies. Finally, LSMSA estimates \$150,000 for professional services contracts for the rebranding of the school which may also include the logo redesign.

The LFO believes much of these anticipated costs can be absorbed through LSMSA's existing operating budget over an extended period of time through the normal supply re-ordering process. To the extent, LSMSA waits to re-order supplies with the new name (such as letter head, business cards, and badges) until after current supplies run out, additional costs will not be incurred. The LFO questions whether the redesign efforts could be accomplished using existing resources and talents of LSMSA and Northwestern State University students and staff. Furthermore, it appears that the rebranding of the school may be outside the scope of the proposed name change.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
