2	To amend and reenact R.S. 39:57.1(B) and to enact R.S. 39:57.1(C) and 73(C)(5), relative
3	to state expenditures; to provide for initial expenditure allocations of the operating
4	budget; to provide for reporting of changes to initial expenditure allocations; to
5	provide for the reporting of certain transfers of funds; to require electronic posting
6	of certain information; to provide for exceptions; to provide for an effective date; and
7	to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 39:57.1(B) is hereby amended and reenacted and R.S. 39:57.1(C) and
10	73(C)(5) are hereby enacted to read as follows:
11	§57.1. Allocation of expenditures; notice and reporting of changes
12	* * *
13	B. Additionally, the commissioner may shall review and approve the initial
14	allocation of expenditures by category for each appropriation for a fiscal year.
15	C.(1) The Joint Legislative Committee on the Budget shall be provided
16	written notification, including detailed justification, of any planned changes or
17	transfer of funds from one category of expenditure to another category.
18	(2) Any change in expenditures or any transfer of expenditures between
19	categories of fifty thousand dollars or more shall require reporting to the Joint
20	Legislative Committee on the Budget.
21	(3) If any agency has made changes in expenditures or transfers of
22	expenditures between categories that cumulatively total one hundred thousand

1	dollars or more for the fiscal year, all subsequent changes in expenditures or
2	transfers of expenditures between categories shall require reporting to the Joint
3	Legislative Committee on the Budget.
4	(4) Paragraphs (2) and (3) of this Subsection shall not apply in the event of
5	a declared disaster, but any changes in expenditures or transfers of expenditures shall
6	be approved by the commissioner of administration.
7	(5) The commissioner of administration shall post the initial allocation of
8	expenditures and any changes to the allocations of expenditures on the website
9	maintained by the commissioner under R.S. 39:6(C).

15	(5) For all approved transfers of funds as authorized in this Subsection, the
16	commissioner of administration shall:
17	(a) Submit all approved transfers to the Joint Legislative Committee on the
18	Budget.
19	(b) Post all approved transfers on the website maintained by the
20	commissioner of administration under R.S. 39:6(C).
21	(c) Submit a monthly report to the Joint Legislative Committee on the
22	Budget on all approved transfers approved in the prior month and all approved
23	transfers for the current fiscal year. The report shall include the transfers approved

	jointly with the Joint Legislative Committee on the Budget and those that do not
25	require approval by the Joint Legislative Committee on the Budget. The
