ELECTIONS: Provides relative to the placement of voting machines during early voting and on election day

1 AN ACT

2 To amend and reenact R.S. 18:1374, relative to elections; to provide relative to voting
3 equipment; to provide relative to procedures for voting; to provide relative to the
4 duties of election officials; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 18:1374 is hereby amended and reenacted to read as follows:

7 §1374. Equipment of polling places; location of machines

8 A. To the extent possible, the authority charged with the selection of polling
9 places shall designate polling places which are equipped with proper electric current,
10 fixtures, and outlets necessary to properly operate the voting machines and otherwise
11 conduct the election.

12 B.(1) Each voting machine shall be placed inside the polling place and
13 during each day of early voting and on election day shall be in full view of the public
14 from the time the ~~election begins~~ polling place is opened until the last elector has
15 voted.

16 (2) The commissioners and watchers shall be stationed near the voting
17 machines, and the commissioners shall regulate the admission of the voters thereto,
18 and each shall always be in full view of the other election commissioners and
19 watchers and, as far as possible, of the public.

Abstract: Specifies that during each day of early voting and on election day voting machines shall be in full view of the public from the time the polling place is opened until the last elector has voted.

Present law (R.S. 18:1374) provides that to the extent possible, the authority charged with the selection of polling places shall designate polling places which are equipped with proper electric current, fixtures, and outlets necessary to properly operate the voting machines and otherwise conduct the election. Provides that each voting machine shall be placed inside the polling place and be in full view of the public. Provides that the commissioners and watchers shall be stationed near the voting machines, that the commissioners shall regulate the admission of the voters thereto, and that each shall always be in full view of the other election commissioners and watchers and, as far as possible, of the public.

Proposed law retains present law.

Present law provides that the voting machines must be in full view of the public from the time the election begins until the last elector has voted.

Proposed law provides that the voting machines shall be in full view of the public beginning when the polling place is opened, instead of when the election begins, and specifies that the requirement applies during each day of early voting and on election day.
