<u>Present law</u> relative to children returning from foster care, provides that lack of parental compliance in a case plan consists of a parent's:

- (1) Failure to attend scheduled visitation.
- (2) Failure to communicate with child.

SB 211 Engrossed

- (3) Failure to provide their whereabouts and changes affecting case plan.
- (4) Failure to contribute to foster care.
- (5) Repeated failure to comply with programs and rehabilitation services.
- (6) Lack of substantial improvement in recurring problems.
- (7) Persistence of conditions that led to removal.

<u>Proposed law</u> retains <u>present law</u> and adds a parent's failure to test negative for synthetic or other controlled dangerous substances prior to reunification.

Effective upon signature of governor or lapse of time for gubernatorial action.

1. Adds that a parent shall provide a negative test result for all controlled dangerous substances at the completion of a reasonable case plan.
