INSURANCE/HEALTH: Provides that mammography examinations may be conducted through digital tomosynthesis

AN ACT

3	40:1105.13(B), and R.S. 46:975(B)(introductory paragraph),(C)(1), and (D), to enact
4	R.S. 46:975(E) and 975.1, and to repeal R.S. 22:1028(B)(3), relative to mandatory
5	coverage for breast cancer screening services; to define minimum mammography
6	examination for health plan benefits; to define digital breast tomosynthesis; to define
7	mammography examination for state cancer control and prevention programs; to
8	designate certain breast cancer screening services as Medicaid covered services; to
9	repeal outdated provisions; to provide for an effective date; and to provide for related
10	matters.

Abstract: Authorizes mammography examinations to be conducted through digital breast tomosynthesis.

<u>Proposed law</u> defines "digital breast tomosynthesis" as a radiologic procedure that involves the acquisition of projection images over the stationary breast to produce cross-sectional digital three-dimensional images of the breast.

<u>Present law</u> requires any health coverage plan which is delivered or issued for delivery in this state to include benefits payable for a minimum mammography examination performed no less frequently than the following schedule:

- (1) One baseline mammogram for any woman who is 35 through 39 years of age.
- One mammogram every 24 months for any woman who is 40 through 49 years of age, or more frequently if recommended by her physician.
- (3) One mammogram every 12 months for any woman who is 50 years of age or older.

<u>Proposed law</u> retains <u>present law</u> and further provides that the minimum mammography examination may be conducted through digital breast tomosynthesis.

<u>Present law</u> applies to any new policy, contract, program, or health coverage plan issued on or after Jan. 1, 1992. Further requires any policy, contract, or health coverage plan in effect prior to Jan. 1, 1992, to convert to conform to the provisions of this Subsection on or before the renewal date but in no event later than Jan. 1, 1993.

<u>Proposed law</u> repeals the effective dates and deadlines which have already passed.

Present law applies, effective July 1, 1998, to the Office of Group Benefits programs.

<u>Proposed law</u> retains <u>present law</u> but repeals the effective date which has already passed.

<u>Present law</u> establishes a statewide Breast Cancer Control Program within the Women's Health Program of the La. Dept. of Health, office of public health to provide preventive, health, and medical care that concentrates on breast cancer detection, prevention, and treatment.

Proposed law retains present law.

<u>Present law</u> requires the program to provide mammography examinations routinely according to age requirements established by department regulations, or performed no less frequently than required by a treating physician.

<u>Proposed law</u> retains <u>present law</u> and further provides that the mammography examination may be conducted through digital breast tomosynthesis.

<u>Present law</u> requires the La. Dept. of Health, office of public health to provide a special program of preventive, health, and medical care for women, who otherwise qualify by law, that concentrates on cancer prevention in women. Further requires the program to provide

a minimum mammography examination performed no less frequently than the following schedule provides:

- (1) One baseline mammogram for any woman who is 35 through 39 years of age.
- One mammogram every 24 months for any woman who is 40 through 49 years of age, or more frequently if recommended by her physician.
- (3) One mammogram every 12 months for any woman who is 50 years of age or older.

<u>Proposed law</u> retains <u>present law</u> and further provides that the minimum mammography examination may be conducted through digital breast tomosynthesis.

<u>Present law</u> also requires the program to provide mammography examinations routinely according to age requirements established by department regulations, or performed no less frequently than required by a treating physician

<u>Proposed law</u> retains <u>present law</u> and further provides that the minimum mammography examination may be conducted through digital breast tomosynthesis.

<u>Proposed law</u> requires the minimum mammography examination provided for in <u>proposed</u> law to be a covered service in the Louisiana Medicaid program.

<u>Present law</u> requires any health coverage plan which is delivered or issued for delivery in the state to provide coverage for detection of prostate cancer, including digital rectal examination and prostate-specific antigen testing for men over the age of 50 years and as medically necessary and appropriate for men over the age of 40 years. <u>Present law</u> applies to any new policy, contract, program, or health coverage plan issued on and after Jan. 1, 1998 and requires any policy, contract, or health coverage plan in effect prior to Jan. 1, 1998, to convert to conform to the provisions of <u>present law</u> on or before the renewal date, but no later than Jan. 1, 1998.

<u>Proposed law</u> retains <u>present law</u> but repeals all of the effective dates and deadlines which have already passed.

<u>Proposed law</u> applies to any new policy, contract, program, or health coverage plan issued on and after Jan. 1, 2019. Any policy, contract, or health coverage plan in effect prior to Jan. 1, 2019, shall convert to conform to the provisions of <u>proposed law</u> on or before the renewal date, but no later than Jan. 1, 2019.

Effective Jan. 1, 2019.
