ENVIRONMENT/LITTERING: Correct statutory references for the litter program from the Department of Environmental Quality to the Department of Wildlife and Fisheries

AN ACT

2 To amend and reenact Chapter 20 of Subtitle II of Title 30 of the Louisiana Revised States 3 of 1950 comprised of R.S. 30:2501 through 2521, the heading of Part I of Chapter 4 21 of Subtitle II of Title 30 of the Louisiana Revised Statutes of 1950, R.S. 5 30:2531(C)(4), R.S. 47:463.43(Section Heading), and R.S. 56:10(B)(15) and to repeal R.S. 30:2521 through 2530, 2537 through 2543, and 2546(D) and R.S. 6 7 36:239(B)(6), relative to environmental education and litter reduction; to provide 8 relative to the powers, duties, functions, and responsibilities of the Department of 9 Wildlife and Fisheries relative to environmental education and litter reduction; and 10 to provide for related matters. 11 Be it enacted by the Legislature of Louisiana: Section 1. §2502. Legislative findings

A. It is in the public interest that a comprehensive and balanced environmental education initiative be undertaken that will result in environmentally literate citizens who will effectively and constructively solve existing environmental problems, prevent new ones, and maintain a sustainable environment for future generations. The appropriate audiences for environmental education include formal education, business, government, nonprofit organizations, and citizens.

- B. Characteristics of an environmentally literate citizenry must include:
- (1) An understanding of the right of every person to own, control, use, enjoy, and dispose of private property, subject only to reasonable regulation.
- (2) An understanding that the Louisiana Constitution requires the use of a balancing process in environmental protection decisions in which environmental costs and benefits must be given full and careful consideration along with economic, social, and other factors.
- (3) Ecological literacy, including a basic understanding of ecological principles and concepts and their application, the cause and effect relationship between human health and the environment, and the economics of that relationship.
- (4) Civic literacy, including a basic understanding of the decisionmaking processes of governments, business, and other social, political, and economic institutions impinging upon environmental issues.
- (5) Mathematical, technological, and scientific literacy, including an understanding of the basic concepts of mathematics and science to evaluate environmental problems and make sound decisions regarding their resolution.
- (6) Personal and social action skills, including developing and using skills such as problem solving, risk analysis, and integrating diverse perspectives to understand and contribute to decision-making processes.
- (7) Attitudes, including the expression of care for other humans, present and future, and for other components of the environment. These attitudes also affect understanding of ecology and civic responsibility.

1	(8) Motivation for action, including the commitment to act for a healthy
2	environment based on one's attitudes, knowledge, and skills.
3	C. The legislature declares that it is the intent of this Chapter to create a
4	balanced statewide environmental education program for the purpose of identifying
5	the needs and setting priorities for environmental education within the state.
6	§2503. Louisiana Environmental Education Commission; creation; membership;
7	duties
8	A.(1) There is hereby created, within the Department of Wildlife and
9	Fisheries, the Louisiana Environmental Education Commission, hereinafter referred
10	to as the "commission".
11	(2) The commission shall consist of the secretary of the Department of
12	Wildlife and Fisheries or his designee, the state superintendent of education or his
13	designee, the secretary of the Department of Environmental Quality or his designee,
14	the secretary of the Department of Natural Resources or his designee, the secretary
15	of the Louisiana Department of Health or his designee, the commissioner of the
16	Department of Agriculture and Forestry or his designee, the chancellor of the
17	Louisiana State University Agricultural Center or his designee, the chancellor of
18	Southern University Agricultural and Mechanical College or his designee, and the
19	following members appointed by the governor:
20	(a) One member of the Board of Regents or his designee.
21	(b) Two members representing environmental advocacy organizations.
22	(c) Two members representing the industrial community.
23	(d) One member representing the small business community.
24	(e) One member representing local governments.
25	(f) One member of the Board of Elementary and Secondary Education.
26	(g) One member who is a professional environmental scientist.
27	(h) Seven environmental educators, one from each congressional district and
28	the remaining environmental educator or educators from the state at large, to be

4	(j) The secretary of the Department of Culture, Recreation and Tourism or

6	B. The initial term of the members of the commission shall be staggered in
7	one, two, or three-year increments. After the initial term, all future terms shall be for
8	three years. Annually, in December of each year, the commission shall elect a
9	chairman and vice chairman whose terms shall commence on the following January
10	first and end on December thirty-first.
11	C. The commission shall:
12	(1) Develop, review, approve, and transmit a plan for environmental
13	education to the governor, the legislature, and the public.

14	materials, the unsolicited distribution of which is protected by the Constitution of the
15	United States or the Constitution of Louisiana. Litter shall not include agricultural
16	products that are being transported from the harvest or collection site to a processing
17	or market site if reasonable measures are taken to prevent the agricultural product
18	from leaving the transporting vehicle. Litter shall also not include recyclable
19	cardboard being transported in compressed bundles to processing facilities.
20	"Agricultural product" as used in this definition means all crops, livestock, poultry,
21	and forestry, and all aquacultural, floracultural, horticultural, silvicultural, and
22	viticultural products.
23	(5) "Local governing authority" means the governing authority of the parish
24	or the governing authority of the municipality in which the littering offense was
25	committed.
26	(6) "Public or private property" means the right-of-way of any road or
27	highway, levee, any body of water or watercourse or the shores or beaches thereof,
28	any park, playground, building, refuge, or conservation or recreation area, and
29	residential or farm properties, timberlands, or forests.

4	§2524. §2505. Donations and grants; Louisiana Litter Abatement Grant Program
5	A. The section is hereby authorized to accept, administer, and make use of
6	federal, state, and any local and private appropriations, any public and private grants
7	and donations, and, when it is deemed appropriate and feasible, to accept
8	nonmonetary funding in the form of services or equipment for use in connection with
9	any of the programs or purposes of this Part.
10	B.(1) The Louisiana Litter Abatement Grant Program is hereby created
11	within the section for the purpose of supporting community-based litter abatement
12	programs.
13	(2) Grants through the program shall be made available to local governments
14	and nonprofit organizations. Funding through the grant program shall be subject to
15	the availability of funds and shall be awarded on a comparative basis to be
16	determined by the section.
17	(3) The monies awarded through the grants shall be used to further the
18	administration and execution of the Keep Louisiana Beautiful Program. Allowable
19	uses of grant funding shall include but not be limited to the following:
20	(a) Keep America Beautiful fees.
21	(b) Keep America Beautiful pre-certification training, education curriculums,
22	and workshops.
23	(c) Law enforcement seminars.
24	(d) Litter surveys.
25	(e) Projects, services, activities, and operational costs of litter abatement
26	programs.
27	(f) Materials and services for program development and training.
28	(g) Direct expenditures for materials that can facilitate litter reduction,
29	recycling, waste reduction, reuse, and general solid waste management programs.

1	(h) Minimal advertising, public relations, and promotional materials
2	necessary for publicity and promotion of program activities.
3	(i) Salary of the program coordinator and staff.
4	(4) Each successful applicant shall supplement grant funds with a
5	twenty-five percent match from other sources. All matching funds must be available
6	to the program after the date of the grant award, and funds spent prior to the grant
7	award shall not be considered in fulfillment of the match requirement.
8	(5) The department, in cooperation with the section, shall promulgate rules
9	and regulations to implement this Subsection which shall include but not be limited
10	to program submission and program administration requirements.

12	and Litter Reduction Section; staff; powers and duties; cooperation; funding
13	A. There is hereby created, within the Department of Wildlife and Fisheries,
14	office of wildlife, the environmental education and litter reduction section which
15	shall, under the direction of its coordinator, assist the commission and perform
16	responsibilities relative to education and litter control as provided for in this Chapter.
17	Insofar as funds are appropriated, additional staff shall be allowed may be employed
18	under the direction and control of the secretary and in accordance with policies of the

7	and non-formal, through cooperation with the Board of Regents and the state's
8	colleges and universities.
9	(5) (6) To cooperate Cooperate with state and federal agencies and the
10	private sector in developing, promoting, conducting, and evaluating programs of
11	environmental education.
12	(6) (7) To function Function as an environmental education clearinghouse
13	by doing the following:
14	(a) Reviewing and recommending environmental education materials
15	(b) Establishing an electronic capacity to disseminate databases of
16	environmental education information, formal and non-formal, and to network with
17	interstate and federal programs.
18	(c) Cooperating with state and federal agencies and organizations in the
19	development and distribution of an environmental education newsletter.
20	(7) (8) To promote Promote the development of cooperative environmental
21	education initiatives with the private sector.
22	(8) (9) To initiate Initiate, develop, implement, assess, and market
23	non-formal environmental education programs; facilitate, encourage, and support
24	multi-school district cooperative efforts to determine the need for, develop, and
25	assess environmental education curricula, promote state government and private
26	sector policy that is consistent with the environmental education strategic plan
27	established; and coordinate non-formal environmental education with elementary,
28	secondary, and postsecondary environmental education programs.

1	(9) (10) To coordinate Coordinate environmental education conferences to
2	assist in the dissemination, development, and achievement of the state's
3	environmental education goals.
4	(10) C. The section shall perform and have implement responsibilities the
5	provisions of this Part relative to litter control awareness, including the following:
6	as provided for in sections 2522, 2524, 2525 beginning with C., 2530, 2537-2541,
7	<del>2547, 2548</del>
8	(1) Develop and implement publicity, educational, and motivational
9	campaigns to build and sustain public awareness of litter and of the unacceptability
10	of littering and to create a litterless ethic.
11	(2) Serve as the coordinating agency between various government and
12	private organizations seeking to aid in litter control and reduction and recycling
13	efforts.
14	(3) Assist local governments in the adoption and revision of ordinances
15	aimed at litter control and reduction.
16	(4) Encourage, organize, and coordinate voluntary campaigns seeking to
17	focus the attention of the public on programs to control and reduce litter and increase
18	public awareness.
19	(5) Provide encouragement of and increased funds for litter cleanup and
20	collection, litter prevention, and cleanup equipment.
21	(6) Promote litter abatement and control and encourage recycling.
22	(7) Promote public awareness and education.
23	(8) Assist local governments, industries, and other organizations which aid
24	in anti-litter efforts.
25	(9) Cooperate with local governments to accomplish coordination of local
26	anti-litter efforts.
27	(10) Encourage, organize, and coordinate voluntary local anti-litter
28	campaigns seeking to focus the attention and participation of the public on the laws

1	of this state enacted to control and remove litter and to provide for the recycling of
2	trash materials.
3	(11) Investigate the availability of and apply for funds from any private or
4	public source to be used for the purposes of this Part.
5	(12) Exchange information directly with judges, district and municipal
6	attorneys, Louisiana state police, and local law enforcement officers on enforcement
7	mechanics and offer technical assistance.
8	(13) Award grants and provide financial assistance on a local level in
9	accordance with rules adopted pursuant to this Part in order to achieve the purposes
10	of this Part and award certificates of achievement for litter abatement.
11	(14) Investigate methods, and monitor effectiveness of this Part and of
12	techniques in the control of litter and develop, encourage, and coordinate litter
13	control within the state.
14	(15) Provide an annual report to the House Committee on Natural Resources
15	and Environment and the Senate Committee on Natural Resources giving details
16	regarding the success of the section's efforts to comply with the above duties or any
17	other duties required of it by law.
18	(16) Approve and disburse financial assistance to any local government or
19	nonprofit organization which, in written application, seeks such assistance to
20	implement a local litter prevention or abatement program.
21	§2529. §2507. Removal of litter; responsibility
22	The duty to remove litter from receptacles placed at publicly-owned publicly
23	owned parks, beaches, campgrounds, trailer parks, roadside parks, and other property
24	shall remain with those state and local agencies performing litter removal within
25	their respective jurisdictions. The duty to remove litter from litter receptacles placed
26	on private property which is used by the public shall remain with the owner.
27	§2530. §2508. Anti-litter campaign; industrial and civic cooperation requested
28	In order to aid in the statewide anti-litter campaign authorized by this Part,
29	the commission and the section shall may solicit the assistance and active

cooperation of industry and private civic organizations which are active in anti-litter
efforts with the commission and the section or a local government as approved under
authority of this Part so that additional effect may be given to the campaign to
eradicate litter within the state.

#### §2537. §2509. Adopt-a-beach program

In order to fulfill the obligations and responsibilities assigned to it under R.S. 30:2521, the section shall may develop a program to be known as "adopt-a-beach", whereby an industry or a private civic organization may adopt one mile of Louisiana beach for the sole purpose of controlling litter along that section of beach. Included in the responsibilities of any industry or private civic organization which chooses to participate in the program shall be the following:

- (1) Development of a functional plan to influence and encourage the public to improve the appearance of the adopted section of beach.
  - (2) A general <del>clean up</del> clean-up of the area at least twice a year.
  - (3) Assistance to the section in securing media coverage for the program.

## §2538. §2510. Trash bash program Community improvement program

In order to fulfill the obligations and responsibilities assigned to it under R.S. 30:2521, the section shall develop may coordinate a community improvement program known as "trash bash program", whereby an annual coordinated cleanup shall may be conducted during the spring Easter weekend encouraging local groups to clean streets, alleys, public areas, adopted roads and beaches, and state and parish highways in surrounding areas. Beautification programs shall may be conducted along with the trash bash program clean up programs at schools, public buildings and grounds, median areas, entrances to subdivisions, commercial areas, and other similar areas. Graffiti removal and excess signage removal programs shall may be held simultaneously.

In order to fulfill the obligations and responsibilities assigned to it <del>under R.S.</del> 30:2521, the section <del>shall</del> may <del>develop a program known as "</del> propose and encourage

beach sweep program' programs whereby an annual coordinated cleanup shall cleanups may be conducted of on the state's seventy-six miles of beaches. The beach sweep program shall be conducted in September along with the other gulf states, and shall may consist of removing debris and trash while conducting data collection to ascertain sources of on marine debris.

In order to fulfill the obligations and responsibilities assigned to it under R.S. 30:2521, the section shall develop a program known as " may promote and encourage inland water cleanup" cleanups whereby a waterway cleanup shall may be conducted annually by local groups to clean rivers, bayous, lakes, streams, and other waterways encouraging beautification through proper waste disposal and handling and placement of litter receptacles at parking lots and dock sites bordering waterway entrances and exits removal of litter and debris.

§2541. §2513. Boaters' and fishermen's pledge

In order to fulfill the obligations and responsibilities assigned to it under R.S. 30:2521, the section shall develop may promote and encourage a program known as "boaters' and fishermen's pledge" whereby the program shall may be conducted asking sportsmen to sign a commitment to bring trash and debris generated in their vehicle or boat back home or to proper disposal receptacles.

§2547. §2514. Adopt-a-byway program

A. In order to fulfill the obligations and responsibilities assigned to it under R.S. 30:2521, the section shall may develop promote and encourage a program to be known as "adopt-a-byway", whereby an organization which owns, uses, or leases property adjacent to a parish maintained road may adopt a section of such road for the sole purpose of controlling litter along that section. Included in the responsibilities of any organization which chooses to participate in the program shall may be the following:

(1) Development of a functional plan to influence and encourage the public to improve the appearance of the adopted section of the road.

2	(3) Assistance to the section in securing media coverage for the program.
3	B. Any parish or municipality which develops an "adopt-a-byway" program
4	shall coordinate the adoption of rules governing the program with the section.

6	may use funds received from the collection of fines provided for under the provisions
7	of R.S. 30:2532(A) to place a sign upon a portion of a road identifying the
8	organization which has adopted such portion of the road.

10	may promulgate rules and regulations to implement the provisions of this Section
11	regarding the placement, construction, and maintenance of the signs provided for in
12	this Section.

14	A. In order to fulfill the obligations and responsibilities assigned to it under
15	R.S. 30:2521, the section shall develop may promote and encourage a program to be
16	known as "Adopt a Water Body", whereby a business or a private civic organization
17	may adopt a portion of a public bayou, stream, creek, river, or lake for the sole
18	purpose of controlling litter. Included in the responsibilities of any business or
19	private civic organization which chooses to participate in the program shall be the
20	following may be as follows:
21	(1) Development of a functional plan to influence and encourage the public
22	to improve the appearance of the adopted portion of a public water body.
23	(2) A general cleanup of the area at least twice a year.
24	(3) Assistance to the section in securing media coverage for the program.
25	B. Any organization which adopts a portion of a public bayou, stream, creek,
26	river, or lake may place a sign identifying the organization on an interstate highway
27	or state highway within two hundred feet of the adopted water body upon approval
28	of the Department of Transportation and Development. Such a sign may also be

placed on the bank of the adopted water body with the approval of the riparian
landowner.
