Creates the Healthy Moms, Healthy Babies Advisory Council

<u>Proposed law</u> creates the Healthy Moms, Healthy Babies Advisory Council and places it within the LA Dept. of Health.

<u>Proposed law</u> provides for the council's duties and membership and requires the Secretary of LDH to convene the council's initial meeting on October 1, 2018 and at least quarterly thereafter. <u>Proposed law</u> states that members of the council shall serve without compensation. <u>Proposed law</u> requires LDH staff to support the council. <u>Proposed law</u> requires the council to perform certain duties, including issuing a report of its findings no later than February 1, 2020. <u>Proposed law</u> creates a public records exception associated with records of the council. <u>Proposed law</u> allows for the publication of certain data which do not identify any individual persons. Proposed law terminates on March 31, 2021.
