<u>Proposed law</u> updates the transfer of agencies to the Louisiana Department of Health (LDH) provisions to remove repealed and obsolete citations and references and categorizes those entities statutorily created within the department.

<u>Present law</u> transfers and places the Board of Veterinary Medicine in the Louisiana Department of Health. <u>Proposed law</u> transfers the Board of Veterinary Medicine <u>from</u> the Louisiana Department of Health <u>to</u> the Department of Agriculture and Forestry.

<u>Present law</u> lists all board members and their qualifications to serve on the boards of agencies within LDH. <u>Proposed law</u> adds at least one consumer member to any board that did not previously have one and provides standardized eligibility criteria of consumers to serve on any board.

<u>Proposed law</u> provides that the governor shall ensure that his appointments demonstrate race, gender, ethnic, and geographical diversity.

<u>Present law</u> provides for professional trade associations and other entities to select and submit nominees to the governor for board appointment. <u>Proposed law</u> opens board nomination eligibility to any member licensed by the board who is interested and eligible. <u>Proposed law</u> requires the board to send notice to its licensees to fill board positions and submit the names of those interested and eligible to serve to the governor for board appointment.

<u>Proposed law</u> increases the number of board members for the Louisiana State Board of Examiners of Psychologists <u>from</u> five to six. <u>Proposed law</u> increases the number of board members for the Louisiana Behavior Analyst Board <u>from</u> five to seven.

- 5. Removes the radiological physicist appointee and restores a hospital administrator appointee to the Louisiana State Radiologic Technology Board of Examiners.
- 6. Restores nominating entities for appointments to the Louisiana State Board of Medical Examiners.
