EDUCATION ACCOUNTABILITY. Provides relative to information provided with the release of school performance scores and letter grades. (gov sig)

AN ACT

2	To enact R.S. 17:10.1(H), relative to school and district accountability; to provide relative
3	to information to be provided with the annual release of school and district
4	performance scores and letter grades; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 17:10.1(H) is hereby enacted to read as follows:
7	§10.1. School and district accountability system; purpose; responsibilities of state
8	board
9	* * *
10	H.(1) For the 2017-2018 school year, the state board shall publish the
11	school and district performance scores and letter grades calculated pursuant to
12	the rules in effect for the reporting of results for the 2016-2017 school year and
13	those calculated pursuant to the current rules in effect for the reporting of
14	results for the 2017-2018 school year. The performance scores and letter grades
15	derived from using both methodologies shall be displayed side by side to
16	facilitate easy comparison.
17	(2) For the 2018-2019 school year and beyond, whenever the state board

makes any significant change in the criteria, methodology, or manner of calculating and determining the school and district performance scores and letter grades that could result in a significant number of schools or districts experiencing a change in letter grade, the board shall consider whether to publish the performance score and letter grade that would have been calculated and reported, had the change not been implemented.

Section 2. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval.

<u>Present law</u> provides for a school and district accountability system that requires the State Board of Elementary and Secondary Education (BESE) to develop criteria to calculate a performance score and letter grade for each school and school district.

<u>Proposed law</u> retains <u>present law</u> and additionally provides that for the 2017-2018 school year BESE shall report school and district performance scores and letter grades calculated in both the manner provided for in current BESE rules and the rules in effect for reporting the 2016-2017 school year. Further provides that the scores to be reported and displayed side by side to facilitate easy comparison.

<u>Proposed law</u> provides that for 2018-2019 school year and beyond, whenever BESE makes significant changes in the criteria, methodology or manner of calculating and determining the school and district performance scores and letter grades that may result in a significant number of schools or districts experiencing a change in letter grade, BESE shall consider publishing the performance score and letter grade in the manner provided for in under the prior rules.

Effective upon signature of the governor or lapse of time for gubernatorial action.

Summary of Amendments Adopted by Senate

<u>Committee Amendments Proposed by Senate Committee on Education to the original bill</u>

1. Requires BESE to report two sets of scores and letter grades for 2017-2018 school year and allows BESE discretion for reporting two sets of scores and letter grades in future years when significant changes are made to the manner in which scores and letter grades are calculated.
