SCHOOLS. Provides relative to school employee participation in student-initiated prayer. (gov sig)

1	AN ACT
2	To amend and reenact R.S. 17:2115.11, relative to student-initiated prayer; to provide
3	relative to school employee participation in student-initiated prayer; to provide for
4	conditions; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 17:2115.11 is hereby amended and reenacted to read as follows:
7	§2115.11. Prayer; student-initiated; conditions
8	A.(1) Upon the request of any public school student or students, the proper
9	school authorities may permit students to gather for prayer in a classroom,
10	auditorium, or other space that is not in use, at any time before the school day begins
11	when the school is open and students are allowed on campus, at any time after the
12	school day ends provided that at least one student club or organization is meeting at
13	that time, or at any noninstructional time during the school day. A school employee
14	may be assigned to supervise the gathering if such supervision is also requested by
15	the student or students and the school employee volunteers to supervise the
16	gathering.
17	B.(2) Any school employee may attend and participate in the gathering if it

1	occurs before the employee's work day begins or after the employee's work day ends.
2	C.(3) Any parent may attend the gathering if the parent adheres to school
3	procedures for approval of visitors on the school campus.
4	D.(4) The students may invite persons from the community to attend and
5	participate in the gathering if other school organizations and clubs are allowed to
6	make similar invitations. Such persons shall adhere to school procedures for approval
7	of visitors on the school campus.
8	B. Notwithstanding the provisions of Subsection A of this Section, a
9	school employee may, upon request of a student or students, attend and
10	participate in a gathering or pray with students during the employee's work
11	day, provided that:
12	(1) The parent or legal guardian of each student in attendance at the
13	gathering or with whom the employee prays has submitted a signed request that
14	the employee may participate in the gathering or pray with his child.
15	(2) Attendance and participation in the gathering or prayer does not
16	interfere with the employee's prescribed work duties.
17	Section 2. This Act shall become effective upon signature by the governor or, if not
18	signed by the governor, upon expiration of the time for bills to become law without signature
19	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
20	vetoed by the governor and subsequently approved by the legislature, this Act shall become
21	effective on the day following such approval.

<u>Present law</u> (R.S. 17:2115.3) provides that no law, rule, or policy may deny any student attending a public elementary or secondary school the right to participate in voluntary, student-initiated, student-led prayer.

<u>Present law</u> (R.S. 17:2115.11) provides conditions for student-initiated prayer and allows school employees to volunteer to supervise student-initiated prayer. Also provides that any school employee may participate in the gathering if it occurs before the employee's work day begins or after the employee's work day ends.

<u>Proposed law</u> retains <u>present law</u> and additionally allows a school employee, upon request of a student or students, to attend and participate in a gathering where there is studentinitiated prayer or to pray with a student during the employee's work day, provided that the parent or legal guardian of each student in attendance at the gathering, or with whom the employee prays, has submitted a signed request that the employee participate in the gathering or pray with his child and such participation does not interfere with the employee's prescribed work duties.

Effective upon signature of the governor or lapse of time for gubernatorial action.
