A CONCURRENT RESOLUTION

2	To designate Wednesday, May 2, 2018, as LMA Municipal Day at the state capitol.
3	WHEREAS, the Louisiana Municipal Association (LMA) was founded in 1926 and
4	is a 501(c)4 nonprofit organization serving as a unified voice for Louisiana's municipal
5	governments; and
6	WHEREAS, the LMA is a statewide member organization that advocates on behalf
7	of three hundred three municipalities and two parishes; and
8	WHEREAS, the LMA also includes five subsidiaries: Risk Management, Inc.,
9	Louisiana Municipal Advisory and Technical Services Bureau (LaMATS), Louisiana
10	Municipal Gas Authority, Louisiana Community Development Authority, and Louisiana
11	Municipal Association of Unemployed Compensation Program; and
12	WHEREAS, the LMA encompasses six affiliate entities: the Louisiana Association
13	of Tax Administrators, Louisiana Recreation and Parks Association, Louisiana City
14	Attorneys Association, Louisiana Municipal Clerks Association, Louisiana Association of
15	Municipal Secretaries and Assistants, and Building Officials Association of Louisiana; and
16	WHEREAS, representation from the affiliate entities and from the Municipal
17	Employees Retirement System of Louisiana, the Louisiana Fire Chiefs Association, the
18	Louisiana Airport Managers and Associates, the Louisiana Conference of Mayors, the
19	Louisiana Municipal Black Caucus Association, and the Louisiana Association of Chiefs of
20	Police is included on the LMA board of directors; and

1 WHEREAS, the mission of the LMA is to advocate, educate, and empower local 2 governments to serve the citizens of Louisiana efficiently and effectively; and 3 WHEREAS, the LMA provides numerous services to its member municipalities, 4 including conferences, training, and webinars; and 5 WHEREAS, the LMA provides LaMATS-sponsored programs such as procurement 6 services, delinquent property tax collection, insurance premium tax collection, municipal 7 debt recovery, blight eradication, and the Computer and Internet Technology Assistance 8 Program; and 9 WHEREAS, the LMA continues to promote local governments by shaping legislation, providing education on municipal issues, and encouraging the exchange of ideas 10 11 and experiences among elected officials throughout the state; and 12 WHEREAS, the LMA is celebrating ninety-two years of advocacy, education, and 13 service; and 14 WHEREAS, on Wednesday, May 2, 2018, the LMA hosts its Annual LMA 15 Municipal Day and Legislative Conference celebrating all municipal officials and employees 16 for their dedication to public service. 17 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 18 designate Wednesday, May 2, 2018, as LMA Municipal Day at the Louisiana state capitol.
