RIVERBOAT GAMING. Provides relative to riverboat gaming. (gov sig)

AN ACT

2	To amend and reenact R.S. 27:15(B)(8)(b), 44(4) and (14) through (25), 65(B)(15), and
3	66(B)(1), and to enact R.S. 27:44(26), 46, 65(B)(16), and 67, relative to the
4	Louisiana Riverboat Economic Development and Gaming Control Act; to provide
5	relative to the Louisiana Gaming Control Board; to provide relative to gaming
6	activity locations; to provide relative to economic development plan applications for
7	relocating gaming operations; to provide relative to requirements of a riverboat; to
8	provide relative to designated gaming area; to provide for tournaments; to provide
9	for limitations; to provide for definitions; to provide for rulemaking; to provide for
10	exceptions; and to provide for related matters.
11	Be it enacted by the Legislature of Louisiana:
12	Section 1. R.S. 27:15(B)(8)(b), 44(4) and (14) through (25), 65(B)(15), and 66(B)(1)
13	are hereby amended and reenacted and R.S. 27:44(26), 46, 65(B)(16), and 67 are hereby

15	§15. Board's authority; responsibilities

9	(4) "Designated gaming area" means that portion of a riverboat in which
10	gaming activities may be conducted. Such designated gaming area shall not exceed
11	sixty percent of the total square footage of the passenger access area of the vessel or
12	thirty thousand square feet, whichever is lesser two thousand three hundred
13	sixty-five gaming positions, subject to the rules and regulations of the board.
14	* * *
15	(14) "Gaming position" means a gaming device seat or a space at a table
16	game. Each gaming device seat shall be counted as one position and each space
17	at a table game shall be counted as one position, subject to the rules and
18	regulations of the board. The board shall specifically provide by rule for the
19	counting of gaming positions for devices and games where seats and spaces are
20	not readily countable.
21	(14)(15) "License" or "gaming license" means a license or authorization to
22	conduct gaming activities on a riverboat issued pursuant to the provisions of this
23	Chapter.
24	(15)(16) "Net gaming proceeds" means the total of all cash and property,
25	including checks received by a licensee, whether collected or not, received by the
26	licensee from gaming operations, less the total of all cash paid out as winnings to
27	patrons.
28	(16)(17) "Non-certificated vessel" means a riverboat vessel which does not
29	hold a Certificate of Inspection issued by the United States Coast Guard. Such

4	(17)(18) "Passenger" means a natural person who is present on a riverboat but
5	has no part in the vessel's operation.

21	Guard with regard to the carriage of passengers on designated rivers or waterways

23	(b) Carries a valid Certificate of Inspection from the United States Coast
24	Guard for the carriage of a minimum of six hundred passengers and crew.
25	(c) Has a minimum length of one hundred fifty feet.
26	(d) Is of such type and design so as to replicate as nearly as practicable
27	historic Louisiana river borne steamboat passenger vessels of the nineteenth century
28	era. It shall not, however, be a requirement that the vessel be steam-propelled:
29	(i) Steam-propelled or maintain overnight facilities for its passengers.

6	(24)(25) "Slot machine" means any mechanical, electrical, or other device,
7	contrivance, or machine which, upon insertion of a coin, token, or similar object
8	therein or upon payment of any consideration whatsoever, is available to play or
9	operate, the play or operation of which, whether by reason of the skill of the operator
10	or application of the element of chance, or both, may deliver or entitle the person
11	playing or operating the machine to receive cash, premiums, merchandise, tokens,
12	or anything of value, whether the payoff is made automatically from the machine or
13	in any other manner.
14	(25)(26) "Supervisor" means the person in charge of the division.

16	§46. Quarterly reporting of professional services and employment information
17	A.(1) Each holder of a license as defined in R.S. 27:44(14) shall submit
18	to the board, the Senate Committee on Judiciary B, and the House Committee
19	on the Administration of Criminal Justice the report required by R.S. 27:21.1.
20	(2) The report shall also indicate if the entity providing a professional
21	service is a Louisiana business, a female-owned business, or a minority-owned
22	business.
23	B. In addition to the report required by Subsection A, each holder of a
24	license as defined in R.S. 27:44(14) shall submit to the board, the Senate
25	Committee on Judiciary B, and the House Committee on the Administration of
26	Criminal Justice a report of the demographic information of their workforce,
27	including but not limited to race, gender, and Louisiana residency.

<u>Present law</u> provides for the authority of the Louisiana Gaming Control Board (the board) to regulate all gaming activities and operations in the state.

<u>Proposed law</u> provides that the board shall promulgate rules and regulations necessary for the administration of the provisions of <u>proposed law</u> and otherwise retains <u>present law</u>.

<u>Present law</u> defines "designated gaming area" as that portion of a riverboat in which gaming activities may be conducted. <u>Present law</u> further provides that the designated gaming area may not exceed 60% of the total square footage of the passenger access area of the vessel or 30,000 square feet, whichever is lesser.

Proposed law provides that the designated gaming area may not exceed 2,365 gaming

positions and otherwise retains present law.

<u>Proposed law</u> defines "gaming position" as a seat at a gaming device or a space at a table game with each device seat counted as one position and each space at a table game counted as one position, subject to the rules and regulations of the board. <u>Proposed law</u> specifically requires the board to provide by rule for the counting of gaming positions for devices and games where seats are not readily countable.

<u>Present law</u> provides that a riverboat must be paddlewheel driven.

<u>Proposed law</u> deletes <u>present law</u> requirement and provides that a riverboat does not have to have an operable paddlewheel or be paddlewheel-driven.

<u>Proposed law</u> adds a facility that is approved by the board and has a portion of its designated gaming area located within 1,200 feet of a riverboat's licensed berth to the definition of "riverboat". Further provides for the inspection of such facilities.

<u>Proposed law</u> requires quarterly reporting of professional services and employment information to the board, the Senate Committee on Judiciary B, and the House Committee on the Administration of Criminal Justice. Specifics what information is to be contained in the report.

<u>Proposed law</u> provides that licensees may not conduct more than four tournaments per year in which the gaming positions utilized for tournament play are not considered part of the licensee's total number of gaming positions. Further provides that such tournaments cannot be more than fourteen days in length.

<u>Proposed law</u> provides that a licensee may submit an application to the board to move its gaming operations to a facility located within 1,200 feet of the riverboat's licensed berth.

<u>Proposed law</u> provides that such an application must include the licensee's relocation plan, detailed capital improvement and reinvestment plan, and any other information required by the board.

<u>Proposed law</u> provides that the board shall prescribe the form and manner of submission for economic development relocation applications.

<u>Proposed law</u> provides that the gaming operations of a licensee be conducted in accordance with the terms of the license, the requirements of this Title, and rules and regulations adopted by the board.

Effective upon signature of the governor or lapse of time for gubernatorial action.

## Summary of Amendments Adopted by Senate

## Committee Amendments Proposed by Senate Committee on Judiciary B to the original bill

- 1. Clarifies the definition of "riverboat" by providing that the facility must have a portion of the designated gaming area within 1,200 feet of the riverboat's licensed berth.
- 2. Adds that licensees may conduct no more than four tournaments per year in which the gaming positions used for tournament play are not counted as part of the licensee's total number of gaming positions and that such tournaments

can take place outside the designated gaming area and cannot be more than fourteen days in length.

## Senate Floor Amendments to engrossed bill

- 1. Adds a provision requiring quarterly reporting of professional services and employment information.
- 2. Removes <u>proposed law</u>'s provision allowing riverboat licensees to conduct certain tournaments outside the designated gaming area which will not be counted as part of the licensee's total number of gaming positions.
- 3. Makes technical corrections.
