HOUSE CONCURRENT RESOLUTION NO. 55

BY REPRESENTATIVES HOFFMANN, BAGLEY, COX, HENSGENS, HORTON, POPE, RICHARD, AND STOKES

HEALTH CARE/PROVIDERS: Urges certain healthcare providers to disseminate information to patients concerning bone marrow donations

A CONCURRENT RESOLUTION

2	To urge and request the Louisiana State Board of Medical Examiners and the Louisiana
3	State Board of Nursing to disseminate information concerning bone marrow
4	donations to healthcare providers for the purpose of enhancing public awareness of
5	bone marrow donations.
6	WHEREAS, since 1987, when the United States Congress authorized the
7	establishment of a national registry of volunteer bone marrow donors, the National Marrow
8	Donor Program, now publicly known as Be The Match, has facilitated more than seventy-
9	four thousand marrow and umbilical cord blood transplants; and
10	WHEREAS, Be The Match states that the number of transplants facilitated through
11	the national Be The Match Registry is only a fraction of the people who can benefit; and
12	WHEREAS, one of the leading hurdles cited in a report by the United States
13	Government Accountability Office is locating a suitably matched, unrelated donor, a process
14	that is often difficult, time-consuming, and costly; and
15	WHEREAS, seventy percent of patients do not have a donor in their family and rely
16	upon the national registry to find a match; and
17	WHEREAS, there is a need to enhance the understanding of the importance of bone
18	marrow donation, and to encourage residents of Louisiana to participate in bone marrow
19	donation drives; and
20	WHEREAS, the bone marrow registration process is simple as it takes only a few
21	minutes and requires a cheek swab; and

1 WHEREAS, a bone marrow transplant may be the best treatment option or the only 2 potential for a cure for patients with leukemia, lymphoma, sickle cell anemia, and many 3 other diseases; and 4 WHEREAS, as the science of transplant continues to advance, new diseases are 5 being treated with bone marrow transplants; and 6 WHEREAS, R.S. 40:1263.2 established the Louisiana Organ Transplant Assistance 7 Program within the office of the secretary of the Louisiana Department of Health; and 8 WHEREAS, through the program, the department educates residents of Louisiana 9 about the need for bone marrow donors, the procedures required to become registered as a 10 potential bone marrow donor, including the procedures for determining the person's tissue 11 type, and the medical procedures a donor must undergo to donate bone marrow or other 12 sources of blood stem cells and the attendant risks of the procedure; and 13 WHEREAS, the department is also directed to make special efforts to educate and 14 recruit minority populations to volunteer as potential bone marrow donors; and 15 WHEREAS, currently no provision requires that the Louisiana State Board of 16 Medical Examiners and the Louisiana State Board of Nursing to disseminate information 17 concerning bone marrow donations to healthcare providers. 18 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 19 urge and request the Louisiana State Board of Medical Examiners and the Louisiana State 20 Board of Nursing to disseminate information concerning bone marrow donations to 21 healthcare providers for the purpose of enhancing public awareness of bone marrow 22 donations. 23 BE IT FURTHER RESOLVED that the information the Louisiana State Board of 24 Medical Examiners and the Louisiana State Board of Nursing shall provide concerning bone 25 marrow donations to healthcare providers licensed by the boards, for dissemination to 26 patients, shall include the following: 27 (1) The need for bone marrow donations. 28 (2) Patient populations that would benefit from bone marrow donations. 29 (3) How to join the national bone marrow registry. 30 (4) How to acquire a free buccal swab kit from the national bone marrow registry.

- 6 executive director of the Louisiana State Board of Medical Examiners and the president of
- 7 the Louisiana State Board of Nursing.
