REAPPORTIONMENT/JUDGES: Provides for election sections for the Juvenile Court for the Parish of Jefferson

AN ACT

2 To amend and reenact R.S. 13:1596(B), relative to the Juvenile Court for the Parish of 3 Jefferson; to provide for election sections for the Juvenile Court for the Parish of 4 Jefferson; to provide for the assignment of judgeships for election purposes; and to 5 provide for related matters. 6 Be it enacted by the Legislature of Louisiana: 7 Section 1. R.S. 13:1596(B) is hereby amended and reenacted to read as follows: 8 §1596. Juvenile court for parish of Jefferson; term, qualifications, compensation, 9 and vacation of judges; sessions of court; quarters; support hearing officers 10 election sections 11 12 B.(1) There shall be three judges of the Juvenile Court for the Parish of 13 Jefferson, and for purposes of nomination and election only there shall be three sections of said court, designated as Section "A", "B", and "C", the judges of which 14 15 shall have full and exclusive authority as judges of the Juvenile Court for the Parish 16 of Jefferson and preside over said the court as a separate court of record. The 17 persons presently presiding over Sections "A" and "B" of said court, and their 18 successors in office, shall continue to preside over Section "A" and Section "B" 19 respectively and Section "C" shall be occupied by the first person elected to the

those contained in the file named "2017 Precinct Shapefiles" published on the Louisiana

1 House of Representatives website. The 2017 Precinct Shapefiles are based upon those

2 Voting Districts (VTDs) contained in the 2010 Census Redistricting TIGER/Line Shapefiles

3 for the State of Louisiana as those files have been modified by the staff of the Legislature

of Louisiana to represent precinct changes submitted through June 27, 2017, to the

Legislature of Louisiana by parish governing authorities pursuant to the provisions of R.S.

(B) When a precinct referenced in this Act has been subdivided by action of the parish governing authority on a nongeographic basis or subdivided by action of the parish governing authority on a geographic basis in accordance with the provisions of R.S. 18:532.1, the enumeration in this Act of the general precinct designation shall include all nongeographic and all geographic subdivisions thereof, however such subdivisions may be designated. The territorial limits of the election sections as provided in this Act shall continue in effect without change regardless of any changes made to the precincts by the parish governing authority.

Section 4. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval.

Abstract: Provides for two election sections for the Juvenile Court for the Parish of Jefferson.

Statistical summaries of <u>proposed law</u> as well as maps illustrating proposed election section boundaries accompany this digest. (Attached to hard copies of the bill distributed during session and available as a separate document on the Internet.)

<u>Present law</u> provides for the Juvenile Court for the Parish of Jefferson and provides for three judges of the court, who shall have the same term, possess the same qualifications as district judges, and shall receive a salary equal to the highest salary paid to any district judge in the

parish. Provides that for purposes of nomination and election only there are three sections of the court, designated as Section "A", "B", and "C".

<u>Proposed law</u> provides for two election sections for the Juvenile Court for the Parish of Jefferson and assigns two judges to election section one and one judge to election section two for election purposes.

Provides that the first vacancy occurring in a judgeship of the court after the effective date of <u>proposed law</u> shall be filled by an election held in election section two, and the remaining judgeships shall be assigned to election section one at that time.

<u>Proposed law</u> specifies that precincts referenced in district descriptions in <u>proposed law</u> are those contained in the file named "2017 Precinct Shapefiles" published on the La. House of Representatives website. Specifies that the 2017 Precinct Shapefiles are based upon those Voting Districts (VTDs) contained in the 2010 Census Redistricting TIGER/Line Shapefiles for the state of La. as those files have been modified by the staff of the legislature to represent precinct changes submitted through June 27, 2017, to the legislature by parish governing authorities pursuant to the provisions of present law (R.S. 18:532 and 532.1).

<u>Proposed law</u> additionally provides that when a precinct is subdivided on a nongeographic or geographic basis under <u>present law</u> (R.S. 18:532.1), the general precinct designation in the district description includes all nongeographic and geographic subdivisions of the precinct, and specifies that the territorial limits of the election sections as provided in <u>proposed law</u> shall continue in effect without change regardless of any changes made to the precincts by the parish governing authority.

Population data in the summaries accompanying this digest are derived from 2010 Census Redistricting Data (Public Law 94-171), Summary File for Louisiana. Population data, statistical information, and maps are supplied for purposes of information and analysis and comprise no part of proposed law.

The Committee Amendments Proposed by <u>House Committee on House and</u> Governmental Affairs to the original bill:


- 1. Change the composition of the election sections and specify that the precincts referenced are those contained in the "2017 Precinct Shapefiles" published on the La. House of Representatives website.
- 2. Change the effectiveness of all the provisions to be upon signature of governor or lapse of time for gubernatorial action.
- 3. Make technical changes relative to the assignment of the judgeships to the election sections.

The House Floor Amendments to the engrossed bill:

1. Change the composition of the election sections.

2. Remove provisions for the assignment of Sections A, B, and C of the court to election sections if no vacancy occurs or no election to fill a vacancy is scheduled before the opening of qualifying for the regularly scheduled elections occurring in 2020.
