 Provides relative to payment of group insurance premiums for retirees from the Cameron Parish Sheriff's Office

**Purpose of Bill:** This bill changes insurance eligibility requirements for retiring sheriffs and deputy sheriffs of the Cameron Parish Sheriff's Office hired on or after July 1, 2018. The Cameron Parish Sheriff's Office shall pay in full the premium costs of group hospital, surgical, and medical expense and the first ten thousand dollars of life insurance for all sheriffs and deputy sheriffs entitled to receive benefits from the Sheriff's Pension and Relief Fund. Sheriffs and deputy sheriffs must be at least fifty-five years of age and have at least fifteen years full time service with the Cameron Parish Sheriff's Office. Present law will apply to those hired prior to July 1, 2018.
