BY SENATORS ALLAIN, CHABERT, GATTI, LAMBERT AND LUNEAU

WATER/WATERWAYS. Establishes a task force to study and make recommendations on the issue of public access on the navigable waters of the state.

| 5 | WHEREAS, Louisiana, and particularly its coastline, is home to some of the most |
| 6 | sought-after hunting, fishing, and nature-viewing opportunities in the world; and |
| 7 | WHEREAS, in many cases along the state's coastline, there are no roads or highways |
| 8 | allowing the public to access and enjoy these activities; therefore, the public must rely on |
| 9 | waterways for access; and |
| 10 | WHEREAS, the coastal regions are subject to both public and private ownership, and |
| 11 | due to the constantly changing nature of the coastline, many boundaries delineating the |
| 12 | ownership of state and private properties have either disappeared or have become |
| 13 | indistinguishable, particularly where property has become submerged; and |
| 14 | WHEREAS, in many cases, the state land office has classified the submerged lands |
| 15 | as claimed by the state and the adjoining landowner, causing additional confusion for those |
| 16 | persons attempting to hunt, fish, or partake in other outdoor recreational activities, or for |
| 17 | those who are simply attempting to traverse a body of water to an area clearly open to the |

| 1 | WHEREAS, a broad-based task force is needed to make concrete policy |

| 4 | THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby |
| 5 | create the Public Recreation Access Task Force to study the conditions, needs, and issues |
| 6 | relative to potential public recreation access on the navigable waters of the state and to make |
| 7 | recommendations to the legislature. |
| 8 | BE IT FURTHER RESOLVED that the task force created shall consist of the |
| 9 | following members: |
| 10 | (1) Three members appointed by the Louisiana Sportsmen's Coalition. |
| 11 | (2) One member appointed by the Coastal Conservation Association of Louisiana. |
| 12 | (3) Three sportsman at large appointed by the governor, one of whom is an angler, |
| 13 | one of whom is a water fowler, and one of whom is a deer hunter. |
| 14 | (4) One member appointed by the Louisiana Landowners Association. |
| 15 | (5) One member who is a landowner or lessee east of the Atchafalaya River, |
| 16 | appointed by the governor from a list of three names submitted by the Louisiana Landowners |
| 17 | Association. |
| 18 | (6) One member who is a landowner or lessee west of the Atchafalaya River, |
| 19 | appointed by the governor from a list of three names submitted by the Louisiana Landowners |
| 20 | Association. |
| 21 | (7) One member appointed by Louisiana Sea Grant Program. |
| 22 | (8) One member appointed by the Louisiana State Law Institute. |
| 23 | (9) Two members of the Senate appointed by the president. |
| 24 | (10) Two members of the House of Representatives appointed by the speaker. |
| 25 | (11) The secretary of the Department of Natural Resources or his designee. |
| 26 | (12) The secretary of the Department of Wildlife and Fisheries or his designee. |
| 27 | (13) One member representing environmental interests of the state appointed with |
| 28 | the concurrence of the Nature Conservancy and the Louisiana Audubon Society. |
| 29 | (14) The attorney general or his designee. |
| 30 | (15) The register of the state land office or his designee. |

| 1 | (16) The governor's executive assistant for coastal activities or his designee. |

| 2 | BE IT FURTHER RESOLVED that the task force shall elect a chair at its first |
| 3 | meeting, and shall follow applicable rules for committee procedure found in the Louisiana |
| 4 | Senate Rules of Order. |
| 5 | BE IT FURTHER RESOLVED that the task force shall, by majority vote, have |
| 6 | presented to them any information that it deems necessary for its deliberations from any state |
| 7 | agency or the Louisiana State Law Institute. The task force may also request from any other |
| 8 | source any information that it may need including but not limited to studies, data, reports |
| 9 | or any other information that is germane to its discussion. |
| 10 | BE IT FURTHER RESOLVED that the task force shall make recommendations to |
| 11 | the legislature no later than February 1, 2020, at which time the task force shall cease to |
| 12 | exist, although the task force may disband at an earlier date following a two-thirds vote of |
| 13 | the membership. |
| 14 | BE IT FURTHER RESOLVED that, beginning in September 2018, the task force |
| 15 | shall meet at least once every other month until February 1, 2020, but may meet more often |
| 16 | if the chair or a majority of the membership deem it necessary. |
| 17 | BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the |
| 18 | governor. |
