Amendments proposed by Representative Terry Landry to Engrossed House Bill No. 901

1 AMENDMENT NO. 1

2 On page 1, line 2, after "(introductory paragraph)" insert a comma "," and "K, and L"

3 AMENDMENT NO. 2

4 On page 1, line 3, after "(7)" insert "and (M)"

5 AMENDMENT NO. 3

6 On page 1, delete lines 4 through 6 in their entirety and insert the following:

7                   "special permits; to assess an annual account fee upon the initial purchase of  
8                   a single-trip overweight permit; to provide for the dedication of monies generated  
9                   from the increase in permit fees;"

10 AMENDMENT NO. 4

11 On page 1, at the beginning of line 7, delete "adjusted permit fees;"

12 AMENDMENT NO. 5

13 On page 1, line 10, after "(introductory paragraph)" delete "is" and insert a comma "," and  
14 "K, and L are"

15 AMENDMENT NO. 6

16 On page 1, line 11, after "(7)" delete "is" and insert "and (M) are"

17 AMENDMENT NO. 7

18 On page 1, delete lines 16 through 20 in their entirety and insert the following:

19                   "(7) Beginning on August 1, 2019, all annual and semi-annual weight  
20                   permits shall be increased by one hundred dollars for each permit issued pursuant to  
21                   this Subsection. This increase shall be applicable to all permits statutorily authorized  
22                   on or before August 1, 2017. However, all trucks operating pursuant to the special  
23                   harvest season permit as provided for in R.S. 32:387(C)(3)(d) shall be granted a ten  
24                   percent weight variance if the truck is equipped with scales."

25 AMENDMENT NO. 8

26 On page 2, delete lines 1 through 11 in their entirety

27 AMENDMENT NO. 9

28 On page 2, delete lines 15 through 25 in their entirety and insert the following:

1           "(2) Beginning on July 1, 2019, when a single-trip overweight permit is  
2 purchased, the purchaser's account shall be assessed an annual one hundred dollar  
3 fee upon the initial purchase of the single-trip over weight permit. This fee shall be  
4 assessed in addition to any other fee authorized by this Section. Fees for an  
5 overweight permit shall be as set forth in the following schedules:"

6 AMENDMENT NO. 10

7 On page 2, between lines 26 and 27, insert the following:

8           "K. The monies generated as a result of the increase provided for in  
9 Subsections B and H of this Section shall be dedicated to the Off-System Bridge  
10 Program created by the Department of Transportation and Development to replace  
11 or rehabilitate structurally deficient or functionally obsolete parish structures.

12           ~~K. L.~~ The secretary may promulgate rules and regulations in accordance with  
13 the Administrative Procedure Act as are necessary to enforce the provisions of this  
14 Section.

15           ~~L. M.~~ Notwithstanding any other provision of law to the contrary, the  
16 governor may delegate authority to the secretary to waive the requirements of the  
17 rules and regulations promulgated by the department relative to the issuance of  
18 special permits for purposes of disaster, emergency, or emergency preparedness. For  
19 the purposes of this Subsection, "disaster", "emergency", or "emergency  
20 preparedness" are defined as provided in R.S. 29:723."
