| 6  | Be it enacted by the Legislature of Louisiana:  |
| 7  | Section 1. R.S. 40:2018.4 is hereby amended and reenacted to read as follows:             |
| 8  | §2018.4. Louisiana Obesity Prevention and Management Commission                           |
| 9  | A. There is hereby established in the Louisiana Department of Health a                    |
| 10 | commission designated the Louisiana Obesity Prevention and Management                     |
| 11 | Commission ("commission"), composed of ten members as provided for in this                |
| 12 | Section. The commission may accept and expend grants and private donations from           |
| 13 | any source, including federal, state, public, and private entities, to assist it to carry |
| 14 | out its functions.  |
| 15 | B. The powers, functions, and duties of the commission shall include but not              |
| 16 | be limited to the following:  |
| 17 | (1) Assisting the executive departments and agencies in achieving                         |
| 18 | programmatic goals related to obesity prevention and management. To this end,             |
| 19 | the commission shall provide leadership and support for:                                  |
| 20 | (a) Organizational efforts found necessary to achieve programmatic                        |
| 21 | objectives.   |
| 22 | (b) Articulating standards through the dissemination of materials,                        |
| 23 | identification of expert opinion, identification of alternate means of developing         |
| 24 | effective population-based programs, and development of policy in identified health       |
| 25 | risks.  |

| 17 | C. The commission shall convene its first meeting no later than August 31,             |
| 18 | 2014. At the first meeting the chairman and vice chairman of the commission shall      |
| 19 | be appointed by the secretary of the Louisiana Department of Health with the           |
| 20 | consultation and approval of the commission. The commission may adopt such rules       |
| 21 | of procedure as are necessary to facilitate orderly conduct of its business.           |
| 22 | D. The commission shall be composed of the following members <b>and sector</b>         |
| 23 | representation:  |
| 24 | (1) The secretary of the Louisiana Department of Health, or his designee.              |
| 25 | (2) The state superintendent of education, or his designee.                            |
| 26 | (3) The commissioner of insurance, or his designee.                                    |
| 27 | (4) The president of the Senate, or his designee.                                      |
| 28 | (5) The speaker of the House of Representatives, or his designee.                      |
| 29 | (6) The director of the Pennington Biomedical Research Center, or his                  |

G. The commission shall submit an annual report, including proposed 1 2 legislation if necessary, to the governor and to the health and welfare committees of 3 the Senate and House of Representatives, sixty days prior to the convening of each 4 regular legislative session. The report shall update the legislature on the 5 commission's progress toward full implementation of services and programs in the state to increase increasing prevention and management of the disease of obesity in 6 7 adults and children. H. The legislative authority for the existence of the commission shall cease 8 9 on March 31, 2018 2020. 10 Section 2. This Act shall become effective upon signature by the governor or, if not 11 signed by the governor, upon expiration of the time for bills to become law without signature 12 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 13 vetoed by the governor and subsequently approved by the legislature, this Act shall become 14 effective on the day following such approval.
