#### DIGEST

Appropriates funds for Fiscal Year 2018-2019 for the ordinary operating expenses of the judicial branch of government with total funding of \$180,177,165 from the following sources: \$160,543,390 out of the State General Fund (Direct) [subject to reduction below]; and, \$10,240,925 from statutory dedications out of the Judges' Supplemental Compensation Fund and the Trial Court Case Management Fund, and \$9,392,850 out of Interagency Transfers from the Dept. of Children and Family Services.

Funding for the ordinary operating expenses of the judicial branch of government is provided as follows:

Requires that the appropriations out of the State General Fund (Direct) contained in this Act be reduced by a total amount of \$51,457,584, pursuant to a plan adopted by the Judicial Budgetary Control Board or as provided by the La. Supreme Court.

Provides for restoration of \$46,445,138 in the event of revenue measures being enacted in the 2018 Second Extraordinary Session.

Effective July 1, 2018.

### Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Ways and Means</u> to the original bill:

- 1. Provide for a change in means of financing to decrease State General Fund (Direct) and increase Interagency Transfers from the Dept. of Children and Family Services by \$9,392,850 for support of drug courts and the Court Appointed Special Advocates (CASA) program.
- 2. Add a requirement that appropriations contained in this Act be reduced by a total amount of \$16,588,993, pursuant to a plan adopted by the Judicial Budgetary Control Board or as provided by the La. Supreme Court.
- 3. Remove funding from the District Courts appropriation for various activities, staff, officers, and functions for the Criminal Court for Orleans Parish in the total amount of \$3,731,858.

1. Restores funding for the District Courts appropriation for various activities, staff, officers, and functions for the Criminal Court for Orleans Parish in the total amount of \$3,731,858.

## Summary of Amendments Adopted by Senate

# <u>The Committee Amendments Proposed by Senate Committee on Finance to the reengrossed bill:</u>

- 1. Reduces appropriation amount by \$51,457,584 State General Fund (Direct).
- 2. Restores \$46,445,138 in the event of revenue measures being enacted in the 2018 Second Extraordinary Session.
