1 A CONCURRENT RESOLUTION

2 To designate Wednesday, May 16, 2018, as Louisiana Housing Council Day at the
3 Legislature of Louisiana and to commend the Louisiana Housing Council for its
4 accomplishments.

5 WHEREAS, the Louisiana Housing Council, or LHC, is composed of over two
6 hundred public housing entities that are subdivided into six regions across the state; and

7 WHEREAS, the LHC promotes and advances the provision of affordable housing
8 to approximately seventeen thousand low-income residents, of which more than one-fourth
9 are elderly and handicapped; and

10 WHEREAS, many of the LHC's member agencies provide a number of services
11 related to housing, including job training, home ownership assistance, protective services,
12 child care, educational assistance, and youth services; and

13 WHEREAS, the LHC strives to create stronger and more dynamic communities and
14 works with other local agencies to enhance the quality of life for citizens throughout the
15 state; and

16 WHEREAS, the LHC awards scholarships to high school students based on academic
17 achievement, extracurricular activities, family need, and community involvement; and

18 WHEREAS, with the presentation of the Phillip W. Miller awards, the LHC honors
19 the achievements of its outstanding members who promote excellence in housing

1 administration with exemplary leadership, high ethical standards, and exceptional
2 management skills; and

3 WHEREAS, the LHC constantly strives to provide decent, safe, and sanitary housing
4 and, in so doing, reduce crime, improve health outcomes, and renovate blighted property,
5 thereby benefitting society as a whole; and

6 WHEREAS, the LHC will hold its annual legislative conference in Baton Rouge on
7 May 16-18, 2018.

8 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
9 designate Wednesday, May 16, 2018, as Louisiana Housing Council Day at the Legislature
10 of Louisiana and does hereby commend the Louisiana Housing Council for its outstanding
11 accomplishments.

12 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted
13 to Pamela Fontenot, president of the Louisiana Housing Council.
