 10 **of the Constitution of the United States of America and by the**
 11 **Constitution of Louisiana, including all forms of peaceful assembly,**
 12 **protest, speech, distribution of literature, carrying signs, and circulating**
 13 **petitions. This expressly excludes commercial activities where**
 14 **individuals or groups are being compensated or attempting to advertise,**
 15 **market, or accrue financial gain to any individual, corporation, business,**
 16 **or organization."**
