- 7 On page 6, delete lines 15 through 19 in their entirety and insert the following:

8	"Section 2. R.S. 18:1300.24 is hereby enacted to read as follows:
9	<u>§1300.24. Election</u>
10	A. A referendum election, as required by Article XII, Section 6(C) of
11	the Constitution of Louisiana, shall be held at the statewide election on
12	November 6, 2018, in each parish which borders a designated river or
13	waterway listed in R.S. 27:43(B)(1) to determine whether the conducting of
14	gaming activity as defined by R.S. 27:44(11) in the portion of the designated
15	gaming area located within one thousand two hundred feet of a riverboat's
16	licensed berth as defined by R.S. 27:44(24)(e) shall be authorized.
17	B. The ballot for the election shall provide as follows: "Shall gaming
18	activity be authorized to be conducted in the portion of the designated
19	gaming area located within one thousand two hundred feet of a riverboat's
20	licensed berth in this parish? YES ( ) NO ( )"
21	C.(1) If a majority of electors in a particular parish in which the
22	proposition election is held vote "YES" to authorize the conducting of
23	gaming activity as defined by R.S. 27:44(11) in the portion of the designated
24	gaming area located within one thousand two hundred feet of a riverboat's
25	licensed berth as defined by R.S. 27:44(24)(e), then such activity shall be
26	authorized in such parish.
27	(2) If a majority of the electors in a particular parish in which the
28	proposition election is held vote "NO" on the proposition to authorize the
29	conducting of gaming activity as defined by R.S. 27:44(11) in the portion of
30	the designated gaming area located within one thousand two hundred feet of
31	a riverboat's licensed berth as defined by R.S. 27:44(24)(e), then such
32	activity shall not be authorized in such parish
33	D. The secretary of state shall prepare the ballot for the election as
34	set forth in the provisions of this Section.
35	E. Except as otherwise provided by this Section, the election shall be
36	conducted in accordance with the Louisiana Election Code.
37	Section 3. The provisions of this Act shall be effective if a majority
38	of qualified electors voting on the proposition, required by the provisions of
39	this Act, in any parish in which the election is held vote "YES" on the
40	proposition to authorize the conducting of gaming in the portion of the

designated gaming area located within one thousand two hundred feet of a
riverboat's licensed berth as provided by this Act."
