HOUSE SUMMARY OF SENATE AMENDMENTS

HB 870 2018 Regular Session Garofalo

PORTS/DEEPWATER: Provides relative to the members of the Louisiana International Deep Water Gulf Transfer Terminal board of commissioners

Synopsis of Senate Amendments

- 1. Makes technical changes.
- 2. Modifies <u>present law</u> by requiring that one member of the board of commissioners be selected from a list of three nominees submitted by the Plaquemines Parish Council.
- 3. Modifies <u>proposed law</u> by requiring that one member of the board of commissioners be selected from a list of two nominees, with the Associated Branch Pilots of the Port of New Orleans, the Crescent River Port Pilots' Association, and the New Orleans-Baton Rouge Steamship Pilots Association jointly submitting one nominee in addition to the nominee submitted by the La. Maritime Association, as provided in proposed law.
- 4. Modifies <u>proposed law</u> relative to the member who may be appointed by the legislative delegation of Plaquemines and St. Bernard parishes to serve on the board of commissioners if the state representative for the House of Representatives district that encompasses the La. Deep Water Gulf Transfer Terminal project chooses not to serve by specifying that the appointee does not have to be a resident of Plaquemines or St. Bernard Parishes if the appointee is a member of the legislative delegation.
- 5. Modifies <u>proposed law</u> relative to that the member who may be appointed by the legislative delegation of Plaquemines and St. Bernard parishes to serve on the board of commissioners if the state senator for the Senate district that encompasses the Louisiana Deep Water Gulf Transfer Terminal project chooses not to serve by specifying that the appointee does not have to be a resident of Plaquemines or St. Bernard Parishes if the appointee is a member of the legislative delegation.
- 6. Modifies <u>proposed law</u> by reducing the number of permissible consecutive terms a commissioner may serve <u>from</u> three <u>to</u> two consecutive terms.

Digest of Bill as Finally Passed by Senate

<u>Present law</u> established a 15 member board of commissioners for the La. International Deep Water Gulf Transfer Terminal, consisting of the secretary of the Dept. of Economic Development and the secretary of the Dept. of Transportation and Development, the chairman of the House and Senate committees on transportation, highways, and public works or their designees and 11 commissioners to be appointed by the governor.

<u>Proposed law</u> reduces the membership of the board <u>from</u> 15 <u>to</u> nine by removing the chairmen of the House and Senate committees on transportation, highways, and public works.

<u>Proposed law</u> requires four members be appointed by the governor: (1) one member from a list of three submitted by the Ports Association of La.; (2) one member from a list of three submitted by the La. Association of Business and Industry; (3) one member at large; and (4)

one member from a list of two submitted by the La. River Pilots' Association and the La. Maritime Association.

<u>Present law</u> requires the commissioners be chosen as follows: one member selected from a list of three nominees submitted by the Ports Association of La.; one member selected from a list of three nominees submitted by the La. Association of Business and Industry; one member selected from a list of three nominees submitted by the La. Maritime Association; one member selected from a list of three nominees submitted by the La. River Pilots Association; two members at large; one member appointed by the American Federation of Labor-Congress of Industrial Organizations; one member selected from a list of three nominees submitted by the president of the La. State Senate; one member selected from a list of three nominees submitted by the speaker of the La. House of Representatives; one member selected from a list of three nominees, who are residents of Plaquemines Parish, submitted jointly by the chief executive officer and the governing authority of Plaquemines Parish; and one member selected by the N.O. Public Belt Railway, and appointed by the governor, who must be a nonvoting member.

<u>Proposed law</u> removes the member from the House that is selected from a list of three names submitted by the speaker of the La. House of Representatives and removes the member from the Senate that is selected from a list of three nominees submitted by the president of the La. State Senate.

<u>Proposed law</u> removes the member selected from a list of three names submitted jointly by the chief executive officer and the governing authority of Plaquemines Parish.

<u>Proposed law</u> removes the member selected by the N.O. Public Belt Railway and appointed by the governor.

<u>Proposed law</u> removes the member that is selected from a list of three names submitted by the La. Maritime Association and the member that is selected from a list of three names submitted by the La. River Pilots' Association, and adds that one member shall be selected from a list of two nominees, with one nominee being jointly submitted by the Associated Branch Pilots of the Port of Orleans, the Crescent River Port Pilots Association, and the New Orleans-Baton Rouge Steamship Pilots Association, and one nominee submitted by the La. Maritime Association.

<u>Proposed law</u> adds one member, who may be the state representative in the House of Representatives district that encompasses the La. International Deep Water Gulf Transfer Terminal project, unless he decides not to serve, at which time a resident of the of Plaquemines or St. Bernard parishes must be appointed by the legislative delegation of Plaquemines or St. Bernard parishes. Further provides that if the appointee is a legislator, the term of the appointment will run concurrent with the term in office. Also provides that if the appointee is a member of the legislative delegation, the member is not required to be a resident of Plaquemines or St. Bernard parishes.

<u>Proposed law</u> adds one member, who may be the state senator in the Senate district that encompasses the La. International Deep Water Gulf Transfer Terminal project, unless he decides not to serve, at which time a resident of the of Plaquemines or St. Bernard parishes must be appointed by the legislative delegation of Plaquemines or St. Bernard parishes. Further provides that if the appointee is a legislator, the term of the appointment will run concurrent with the term in office. Also provides that if the appointee is a member of the legislative delegation, the member is not required to be a resident of Plaquemines or St. Bernard parishes.

<u>Proposed law</u> provides that if the member is a legislator and he is unable to attend a meeting, he may name one person as his designee to act on his behalf who must be included when determining a quorum. Further provides that the designee will have full voting rights.

Present law specifies that the commissioners appointed are appointed for terms of six years

and that no commissioner can serve more than two consecutive terms.

Proposed law relocates this provision.

<u>Present law</u> requires the board of commissioners to seek the approval of the House and Senate committees on transportation, highways, and public works and the Joint Legislative Committee on the Budget prior to the adoption of any rule or regulation for the maintenance and operation of the authority.

Proposed law removes present law.

<u>Present law</u> requires the board of commissioners elect a president, two vice-presidents, a secretary, and a treasurer from among the members of the board.

<u>Proposed law</u> reduces the number of vice-presidents to be elected <u>from</u> two <u>to</u> one.

<u>Present law</u> specifies that all matters to be acted upon by the board of commissioners or the executive board require the affirmative vote of a majority of the board, with the exception that the affirmative vote of not less than 10 commissioners is required to select the executive director.

<u>Proposed law</u> changes <u>present law</u> by requiring the affirmative vote of a majority of the members present constituting a quorum, and reduces the number of affirmative votes of commissioners to select the executive director <u>from</u> 10 to six.

<u>Present law</u> requires the board to make an annual report to the governor, the House and Senate committees on transportation, highways, and public works, and the Joint Legislative Committee on the Budget.

<u>Proposed law</u> removes the Joint Legislative Committee on the Budget from the entities to which the board must make an annual report.

<u>Proposed law</u> specifies that after the effective date of <u>proposed law</u> a member in an unaltered seat will continue to serve the unexpired portion of the term.

Effective July 1, 2018.
