Requires additional training for peace officers

<u>Proposed law</u> directs the Peace Officer Standards Training Council (POST) to incorporate techniques for specific face-to-face communications training for peace officers. <u>Proposed law</u> requires certain peace officers on or after July 1, 2018, to complete the domestic violence awareness training. <u>Proposed law</u> directs the POST council to develop a specific communication training plan that incorporates officer techniques for face-to-face communications with hard of hearing or deaf persons. <u>Proposed law</u> provides for specific peace officers on or after January 1, 2019, to complete a training program as provided for in proposed law. <u>Proposed law</u> directs the POST council to promulgate rules in accordance with the Administrative Procedure Act for the implementation of domestic violence awareness training and communications with deaf or hard of hearing individuals. <u>Proposed law</u> requires the POST council to create and maintain a list of peace officers who successfully completed the domestic violence awareness training and the training on communication with deaf or hard of hearing individuals.

EXPENDITURE EXPLANATION

<u>Proposed law</u> will result in one-time SGF expenditures for the Louisiana Commission on Law Enforcement (LCLE). LCLE reports that development of an interactive video training module to accomplish the goals of <u>proposed law</u> would create a one-time development and implementation cost of approximately \$28,000. <u>Proposed law</u> requires the Peace Office Standards Training Council to approve communication cards developed by any public or private entity, including non-governmental advocacy groups, to be made available for use by law enforcement officers and that all officers shall have these cards available in patrol vehicles. LCLE reports that the cost to create and publish (available for download) the communication card is estimated at \$1,500 for the graphic design of the card. LCLE reports that it can absorb these costs in its existing budget without requiring additional budgetary or staffing resources. State and local law enforcement entities will realize a nominal expenditure associated with reproducing the communication cards for distribution to patrol units on an ongoing basis. LCLE reports that its estimated direct costs of producing and distributing approximately 23,000 communication cards for full-time peace officers statewide would total approximately \$11,500 if it were to produce physical copies instead of distributing for digital download.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
