### BY REPRESENTATIVE THOMAS AND SENATOR LAFLEUR

1	AN ACT
2	To amend and reenact R.S. 17:273.3(C)(2) and (E)(4), to enact R.S. 17:10.1(G)(4),
3	273.2(D), and 273.3(H), relative to foreign language immersion programs in public
4	schools; to provide that such programs can be any type of dual language immersion
5	program in French or Spanish; to require local public school boards to notify parents
6	or legal guardians of certain determinations with regard to requests to establish a
7	program; to provide relative to the review of program requests, program approval
8	and location, and student enrollment in a program; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. R.S. 17:273.3(C)(2) and (E)(4) are hereby amended and reenacted and
11	R.S. 17:10.1(G)(4), 273.2(D), and 273.3(H) are hereby enacted to read as follows:

8	(2)(a) Beginning with the 2014-2015 school year, a local school board, if
9	requested in writing by the parents or legal guardians of at least twenty-five students
10	seeking to be enrolled in kindergarten or of at least twenty-five students seeking to
11	be enrolled in first grade who reside within the jurisdictional boundaries of the
12	school district, shall establish a foreign language immersion program for such
13	students, provided that all of the following apply:
14	(i) The parent or legal guardian of each student commits, in writing, that the
15	student will participate in the program.
16	(ii) The requisite number of written requests are submitted to the local school
17	board not later than March first January thirty-first prior to the school year in which
18	the program is to be established.
19	(iii) The minimum foundation program formula provides funding to local
20	school systems employing foreign language teachers to provide salary supplements
21	for such teachers at a level equal to or greater than the level of funding provided for
22	this purpose through such formula for the 2011-2012 fiscal year.
23	(iv) A sufficient number of foreign language teachers with the required
24	credentials as prescribed by the State Board of Elementary and Secondary Education
25	are available through programs administered by the Department of Education and the
26	Council for the Development of French in Louisiana to establish the program.
27	(v) There is no existing foreign language immersion program offered by the
28	local school board, in the same foreign language being proposed, that has been
29	certified by the State Board of Elementary and Secondary Education pursuant to R.S.
30	17:273.2.

(b) Such program shall be continued as long as at least twenty students remain enrolled in the program.

(c) The local school board shall ensure that any foreign language immersion program established pursuant to this Section is designated as a Certified Foreign Language Immersion Program by the State Board of Elementary and Secondary Education in accordance with R.S. 17:273.2 within three years from the date such program is established.

8 (d) The local school board shall review the written requests submitted 9 pursuant to this Paragraph and shall notify the parents or legal guardians not later 10 than February fifteenth of its determination as to whether or not the required number 11 of requests was submitted.

12 (e) The local school board shall inform the parents and legal custodians of 13 all students enrolled in the school system about the existence of any newly 14 established foreign language immersion program and shall permit all eligible 15 students to apply for the program during the designated enrollment period for the 16 school year.

17 (f) The local school board shall consider the location of all students applying
18 for a foreign language immersion program and shall make reasonable attempts to
19 place the program in schools located near the majority of the students who applied.

E. A local public school board shall not deny enrollment in a foreign language immersion program to any student if all of the following conditions are met:

(4) The student applies for enrollment in such a program by no later than
March first <u>April fifteenth</u> of the school year prior to such enrollment.
