| 8 | Be it enacted by the Legislature of Louisiana: |
| 9 | Section 1. Children's Code Articles 424.2 and 424.4(B) are hereby amended and |
| 10 | reenacted to read as follows: |
| 11 | Art. 424.2. CASA; order of assignment |
| 12 | To accomplish the assignment of a CASA volunteer, the court shall issue an |
| 13 | order of assignment which shall grant the CASA volunteer the authority to review |
| 14 | all relevant documents pursuant to Article 424.6 and to interview all parties and |
| 15 | witnesses involved in the proceeding in which he is appointed. The court may also |
| 16 | grant the CASA volunteer access to the home in which the child is placed. |

| 20 | B. The CASA volunteer shall be notified by the department and shall be |
| 21 | entitled to attend all of all administrative review hearings and family team meetings |
| 22 | concerning the case to which he has been assigned, unless the parent objects. |
