Amendments proposed by Representatives Jim Morris and Abramson to Engrossed Senate

1    AMENDMENT NO. 1

2    On page 1, line 4, after "Institute" and before "to" insert a comma "," and "in consultation  
3    with representatives from various stakeholder organizations and certain legislative  
4    committees,"

5    AMENDMENT NO. 2

6    On page 2, line 10, after "Institute," and before "to" insert "and the individual representatives  
7    from the various stakeholder organizations and legislative committees,"

8    AMENDMENT NO. 3

9    On page 2, between lines 20 and 21, insert the following:

10       "BE IT FURTHER RESOLVED, in addition to representatives of the Louisiana  
11    Mineral Law Institute at Louisiana State University Paul M. Hebert Law Center, the LSU  
12    CES, the LSU PAI, and the Louisiana Tax Institute, the following representatives from  
13    stakeholder organizations shall be included in meetings and discussions regarding state oil  
14    and gas law and state tax law as it relates to oil and gas law and shall be consulted and  
15    included in the group tasked with making specific recommendations to the legislature:

- 16       (1)    A representative selected by the Louisiana Oil and Gas Association.

18       (2)    A representative selected by the Louisiana Mid-Continent Oil and Gas  
19       Association.  
  
20       (3)    A representative selected by the Public Affairs Research Council of  
21       Louisiana.  
  
22       (4)    A representative selected by the Counsel for a Better Louisiana.  
  
23       (5)    A representative selected by the Louisiana Law Institute.  
  
24       (6)    A senator selected by the chair of the Senate Natural Resources Committee.  
  
25       (7)    A senator selected by the chair of the Senate Revenue and Fiscal Affairs  
26       Committee.  
  
27       (8)    A representative selected by the chair of the House Natural Resources  
28       Committee.  
  
29       (9)    A representative selected by the chair of the House Ways and Means  
30       Committee."

4 On page 3, at the end of line 1, after "Institute" and before the period "." insert a comma ","  
5 and insert the following:

7 the Louisiana Mid-Continent Oil and Gas Association, the Board of Directors of the Public  
8 Affairs Research Council of Louisiana, the Board of Directors of the Counsel for a Better  
9 Louisiana, the director of the Louisiana Law Institute, the President of the Senate, and the  
10 Speaker of the House of Representatives"
