| 7 | Be it enacted by the Legislature of Louisiana: |
| 8 | Section 1. R.S. 40:2405.8(E) is hereby amended and reenacted and R.S. 40:2405.8 |
| 9 | (F) and (G) are hereby enacted to read as follows: |
| 10 | §2405.8. Additional peace officer training requirements |
| 11 | * * * |
| 12 | E.(1) The council shall develop a domestic violence awareness training |
| 13 | program in a series of modules to include all of the following: |
| 14 | (a) Dynamics of domestic violence. |
| 15 | (b) Predominant aggressor determination. |
| 16 | (c) Neurobiology of trauma and its implications for victim communication. |
| 17 | (d) Strangulation response and investigation methods. |
| 18 | (e) Evidence-based investigation methods. |
| 19 | (f) Protection order enforcement and the Louisiana Protective Order |
| 20 | Registry. |

| 2 | (2) On and after July 1, 2018, each peace officer, as defined in R.S. |
| 3 | 40:2402(3)(a), shall complete a domestic violence awareness training program as |
| 4 | provided by the council. |
| 5 | <u>F.(1)</u> The council, in collaboration with the community, shall develop a |
| 6 | communication training plan. The plan shall incorporate officer techniques for face- |
| 7 | to-face communications with hard of hearing or deaf persons. The training shall |
| 8 | cover the following topics: |
| 9 | (a) Recognition of deaf or hard of hearing individuals. |
| 10 | (b) Communication tips including but not limited to the following: |
| 11 | (i) Review of the ADA publication, "Communicating with People Who Are |
| 12 | Deaf or Hard of Hearing: ADA Guide for Law Enforcement Officer". |
| 13 | (ii) Training with communication cards or other forms of assistance |
| 14 | technology for law enforcement officers interacting with deaf or hard of hearing |
| 15 | individuals. |
| 16 | (c) Information regarding how to access interpreters, TTY, and relay |
| 17 | services. |
| 18 | (d) Rights of deaf and hard of hearing individuals, including interrogations. |
| 19 | (e) Applicable state and federal laws. |
| 20 | (2) On and after January 1, 2019, each peace officer, as defined in R.S. |
| 21 | 40:2402(3)(a), shall complete an interactive training module as provided by the |
| 22 | council on communicating with deaf and hard of hearing individuals. |
| 23 | (3) The council shall approve communication cards developed by any public |
| 24 | or private entity, including nongovernmental advocacy groups, that specializes in |
| 25 | working with deaf and hard of hearing individuals for the use by law enforcement |
| 26 | officers. The communication cards should be made available in all law enforcement |
| 27 | agency headquarters and substations. Additionally, all officers shall have |
| 28 | communication cards available in patrol vehicles. |
| 29 | <u>E.G.(1)</u> The council shall promulgate rules and regulations in accordance |
| 30 | with the Administrative Procedure Act, subject to the oversight of the House |

| 13 | officers as defined in R.S. 40:2402(3)(a) as provided in Paragraph (C)(3) of this |
| 14 | Section no later than January 1, 2017. |
| 15 | (3)(a) The council shall promulgate rules in accordance with the |
| 16 | Administrative Procedure Act for implementation of the following training programs |
| 17 | for peace officers as provided in Subsections E and F of this Section: |
| 18 | (i) Domestic violence awareness training. |
| 19 | (ii) Communication with deaf or hard of hearing individuals. |
| 20 | (b) The council shall create and maintain a list of peace officers who have |
| 21 | successfully completed the domestic violence awareness training and the training on |
| 22 | communication with deaf or hard of hearing individuals. |
