Webster Parish clerk of court's office, the West Feliciana Parish clerk of court's 1 2 office, or the Winn Parish clerk of court's office who is entitled to receive monthly benefits from the Louisiana Clerks' of Court Retirement and Relief Fund, who has 3 4 at least twenty years of full-time service with the clerk of court's office in Avoyelles 5 Parish, Bossier Parish, Caddo Parish, Calcasieu Parish, Caldwell Parish, Cameron Parish, Franklin Parish, Grant Parish, Iberia Parish, Lafayette Parish, LaSalle 6 7 Parish, Ouachita Parish, Pointe Coupee Parish, St. Martin Parish, Terrebonne Parish, Webster Parish, West Feliciana Parish, or Winn Parish, Orleans Parish 8 9 Civil District Court, or Orleans Parish Criminal District Court, and who is at 10 least fifty-five years of age.
