| 12 | Seven Thousand Five Hundred Eighty-Four and No/100 (\$51,457,584) |
| 13 | (\$49,457,584) Dollars, pursuant to a plan adopted by the Judiciary Budgetary |
| 14 | Control Board or as approved by the Louisiana Supreme Court. |

| 16 | Section 4. Appropriations contained in this Section of this Act shall become |
| 17 | effective upon enactment of certain revenue measures introduced in the 2018 Second |
| 18 | Extraordinary Session of the Legislature, and incorporated into the Fiscal Year 2018- |
| 19 | 2019 official forecast of the Revenue Estimating Conference. The sum of Forty-Six |
| 20 | Forty-two Million Four Hundred Forty-Five Thousand One Hundred Thirty-Eight |
| 21 | and No/100 (\$46,445,138) <u>(\$42,445,138)</u> Dollars is hereby appropriated out of the |
