CRIME: Provides for fines associated with selling tobacco, alternative nicotine, or vapor products to persons under the age of 18

2	To amend and reenact R.S. 14:91.8(H)(1) and to enact R.S. 14:91.8(H)(3), relative to
3	offenses affecting general morality; to provide relative to the unlawful sale,
4	purchase, or possession of tobacco, alternative nicotine, or vapor products; to
5	increase the fines associated with selling tobacco, alternative nicotine, or vapor
6	products to persons under the age of eighteen; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 14:91.8(H)(1) is hereby amended and reenacted and R.S.
9	14:91.8(H)(3) is hereby enacted to read as follows:
10	§91.8. Unlawful sale, purchase, or possession of tobacco, alternative nicotine
11	product products, or vapor product products; signs required; penalties

13	H.(1) A person who violates the provisions of this Section by selling or
14	buying tobacco products, alternative nicotine products, or vapor products shall be
15	fined not more than fifty dollars for the first violation. The penalties for subsequent
16	violations shall be a fine of not more than one hundred dollars for the second
17	violation, a fine of not more than two hundred fifty dollars for the third violation, and
18	a fine of not more than four hundred dollars for any violation thereafter.

4	violations shall be a fine of not more than one thousand dollars for the second
5	violation and a fine of not more than two thousand five hundred dollars for any
6	violation thereafter.

Abstract: Increases the fines associated with selling tobacco products, alternative nicotine products, or vapor products to persons under the age of 18.

<u>Present law</u> prohibits the sale and distribution of any tobacco product, alternative nicotine product, or vapor product to persons under the age of 18, and prohibits persons under the age of 18 from buying such products.

<u>Present law</u> provides that whoever violates <u>present law</u> by selling or buying tobacco products, alternative nicotine products, or vapor products shall be subject to the following fines:

- (1) For a first violation a fine of up to \$50.
- (2) For a second violation a fine of up to \$100.
- (3) For a third violation a fine of up to \$250.
- (4) For subsequent violations a fine of up to \$400.

<u>Proposed law</u> retains <u>present law</u> fines for the under-age buyers and provides for increased fines for sellers who violate <u>present law</u>:

- (1) For a first violation a fine of up to \$500.
- (2) For a second violation a fine of up to \$1,000.
- (3) For subsequent violations a fine of up to \$2,500.
