WORKERS COMPENSATION: Provides for worker's compensation for volunteer reserve police officers

| 6 | Section 1. R.S. 23:1036.1 is hereby enacted to read as follows: |
| 7 | §1036.1. Reserve police officers and deputies; coverage |
| 8 | A. Any reserve police officer or reserve deputy who volunteers for a law |
| 9 | enforcement agency, municipal or parish, and performs law enforcement activities |
| 10 | and protective services and is injured during the line of duty, shall be entitled to |
| 11 | medical benefits pursuant to R.S. 23:1203. Such benefits shall not be subject to a |
| 12 | copayment, deductible, or any other method to shift the cost of compensable medical |
| 13 | care to the injured volunteer reserve officer or deputy. |
| 14 | B. No law enforcement agency shall provide indemnity benefits for the |
| 15 | volunteer reserve police officer or deputy. |
| 16 | C. No law enforcement agency shall be liable for benefits under this Section |
| 17 | for injuries occurring within the course of, or arising out of, the volunteer reserve |
| 18 | officer's or deputy's other employment. |
| 19 | D. For the purposes of this Section, the following terms have the meaning |
| 20 | ascribed to them: |

Abstract: Provides medical benefits for volunteer reserve police officers and deputies who may become injured while the volunteer member is in the line of duty.

<u>Present law</u> provides that a volunteer reserve officer or deputy shall be covered under their own insurance policy.

<u>Proposed law</u> provides that any reserve police officer or deputy who volunteers for a municipal or parish law enforcement agency, shall be entitled to medical benefits pursuant to <u>present law</u> if injured during the line of duty.

<u>Proposed law</u> provides that the injured reserve police officer or reserve deputy shall not be compensated for injuries occurring within the course of, or arising out of, the volunteer reserve officer's or deputy's other employment.

<u>Proposed law</u> provides that the injured volunteer reserve officer or reserve deputy shall not be entitled to be compensated for lost wages.

<u>Proposed law</u> defines the term "volunteer reserve officer" to mean an individual who is carried on the membership list of the municipal organization as an active participant in the normal functions of the law enforcement organization.

<u>Proposed law</u> defines the term "volunteer reserve deputy" as an individual who is part-time, non-salaried, fully-commissioned law enforcement officer who volunteers with the parish organization.
