DENTISTRY. Provides for a direct primary care agreement with a dental practice. (8/1/19)

1	AN ACT
2	To enact R.S. 37:798, relative to direct primary care agreements with a dental practice; to
3	provide definitions; to set forth the written requirements for direct primary care
4	agreements with a dental practice; to provide that a direct primary care agreement
5	does not constitute health or dental insurance; to provide terms and conditions; and
6	to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 37:798 is hereby enacted to read as follows:
9	§798. Direct primary care agreement with a dental practice
10	A. As used in this Section, the following words have the meanings
11	ascribed to them unless the context requires otherwise:
12	(1) "Board" means the Louisiana State Board of Dentistry.
13	(2) "Dentist" means a person licensed to practice dentistry in this state.
14	(3) "Direct primary care agreement" means a written agreement
15	between a direct dental practice and a patient or his or her legal representative
16	whereby the direct dental practice agrees to provide dental services to the
17	patient for an agreed upon fee and period of time.

1	(4) "Direct dental practice" means a dentist or dental practice of a
2	dentist that charges a periodic fee for dental services and which does not bill a
3	third party, including any entity subject to regulation under Title 22 of the
4	Louisiana Revised Statutes of 1950, for any additional fee for services for
5	patients covered under a direct primary care agreement. The per visit charge
6	of the practice shall be less than the monthly equivalent of the periodic fee.
7	B. A direct primary care agreement that complies with the provisions of
8	this Section is not health or dental insurance and is not subject to the provisions
9	or regulations provided for under Title 22 of the Louisiana Revised Statutes of
10	<u>1950.</u>
11	C. A patient or legal representative shall not forfeit any insurance
12	benefits, Medicaid benefits, or Medicare benefits by purchasing healthcare
13	services or products outside the system.
14	D. A direct dental practice offering, marketing, selling, or entering into
15	a direct primary care agreement shall not be required to obtain a certificate of
16	authority or license other than to maintain a current license to practice
17	dentistry in this state.
18	E. To be considered a direct primary care agreement for the purposes
19	of this Section, the agreement shall satisfy all of the following:
20	(1) Be in writing.
21	(2) Be signed by a dentist, or agent of the dentist, and the patient, or his
22	or her legal representative.
23	(3) Allow either party to terminate the agreement upon written notice of
24	at least thirty days to the other party.
25	(4) Describe the scope of dental services that are covered by the periodic
26	<u>fee.</u>
27	(5) Specify the periodic fee and any additional fees outside of the periodic
28	fee for ongoing dental services.
29	(6) Specify the duration of the agreement and any automatic renewal

1	periods and require that no more than twelve months of the periodic fee be paid
2	in advance.
3	(7) Prominently state in writing that is conspicuously visible and in bold
4	font all of the following:
5	(a) The agreement does not constitute health or dental insurance under
6	the laws of this state.
7	(b) Patients insured by health insurance plans that are compliant with
8	the Patient Protection and Affordable Care Act may already have coverage for
9	pediatric dental benefits.
10	(c) Payments made by a patient for services rendered under a direct
11	primary care agreement may not count toward the patient's health insurance
12	deductibles and maximum out-of-pocket expenses.
13	(d) A patient is encouraged to consult with the patient's health insurance
14	plan before entering into the agreement and receiving care.
15	(8) Provide that, upon termination of the agreement by the patient, all
16	unearned fees are to be returned to the patient.
17	F. A direct dental practice may accept payment of periodic fees directly
18	or indirectly from third-parties. A direct dental practice may accept a periodic
19	fee paid by an employer on behalf of an employee who is a direct patient.
20	However, a dental practice shall not enter into a contract with an employer
21	relating to the direct primary care agreements between the direct dental
22	practice and employees of that employer other than to establish the timing and
23	method of the payment of the periodic fee by the employer.
24	G. A direct dental practice shall not decline to accept a new direct
25	primary care patient or discontinue care to an existing patient solely because of
26	a patient's health status, race, religion, national origin, the presence of any
27	sensory, mental or physical disability, education, or economic status. A direct
28	dental practice may decline to accept a patient if either:
29	(1) In the dentist's opinion, the patient's health condition is such that the

1	provider is unable to provide the appropriate level and type of dental services
2	the patient requires.
3	(2) The dental practice has reached its maximum capacity.
4	H. A direct dental practice may discontinue care for patients under the
5	direct primary care agreement under any of the following conditions:
6	(1) The patient fails to pay the periodic fee.
7	(2) The patient has performed an act of fraud concerning the direct
8	primary care agreement.
9	(3) The patient repeatedly fails to adhere to the recommended treatment
10	<u>plan.</u>
11	(4) The patient is abusive or presents an emotional or physical danger to
12	the staff or other patients of the dental practice.
13	(5) The direct dental practice discontinues operation as a dental practice.
14	I. The board may promulgate all rules and regulations that are necessary
15	and proper to effectuate the provisions of this Section.
16	J. A violation of this Section shall constitute unprofessional conduct
17	under R.S. 37:775 and result in sanctions by the board as authorized in this
18	Chapter.

Proposed law provides for a direct primary care agreement with a dental practice.

Defines "board", "dentist", "direct primary care agreement", and "direct dental practice".

Stipulates that a direct primary care agreement with a dental practice is not health or dental insurance.

Provides that a patient shall not forfeit their insurance, Medicaid, or Medicare benefits by purchasing a direct primary care agreement.

Provides that a dentist entering into a direct primary agreement is not required to obtain a certificate of authority or license other than to maintain a current license to practice dentistry in this state.

Requires that a direct primary care agreement must be in writing; be signed by a dentist, or

agent of the dentist, and the patient, or his or her legal representative; allow either party to terminate the agreement with 30-days written notice to the other party; describe the scope of the services to be covered by the fee; specify the periodic fee and any additional fees outside of the periodic fee; specify the duration of the agreement and any automatic renewal periods; require that no more than 12 months of the periodic fee be paid in advance; and, provide that upon termination of the agreement by the patient, all unearned fees are to be returned to the patient.

Requires that the following be prominently stated in writing in the agreement: the agreement does not constitute health or dental insurance; that a patient insured with the Patient Protection and Affordable Care Act may already have coverage for pediatric dental benefits; that payments made may not count toward a patient's health insurance deductibles and maximum out-of-pocket expenses; and, that a patient is encouraged to consult with their insurance plan before entering into the agreement and receiving care.

Allows a direct dental practice to accept payment of periodic fees for a direct primary care agreement directly or indirectly from third-parties, including employers.

Prohibits a direct dental practice from declining a new direct primary care patient or discontinuing service because of a patient's health status, race, religion, national origin, the presence of any sensory, mental or physical disability, education, or economic status.

Allows a direct dental practice to refuse care if in the dentist's opinion, a patient's health condition is such that the provider is unable to provide the appropriate level or type of services or if the dental practice has reached maximum capacity.

Allows a direct dental practice to discontinue care if a patient fails to pay the periodic fee, performs an act of fraud concerning the agreement, repeatedly fails to adhere to the recommended treatment plan, is abusive or presents a danger to the staff or other patients, or the direct dental practice discontinues operations.

Authorizes the board to promulgate rules and regulations to effectuate proposed law.

Provides that violations of <u>proposed law</u> constitute unprofessional conduct under R.S. 37:775 and result in sanctions as authorized in <u>present law</u>.

Effective August 1, 2019.
