CONSUMERS/PROTECTION: Provides relative to telemarketing to elder persons and persons with disabilities

1	AN ACT
2	To enact R.S. 51:1409.1, relative to unfair trade practices; to provide with respect to elder
3	persons and persons with disabilities; to provide for a private right of action; to
4	provide with respect to fraudulent marketing through telephone, electronic mail, or
5	text messaging; to provide for damages; to provide definitions; and to provide for
6	related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 51:1409.1 is hereby enacted to read as follows:
9	§1409.1. Deceptive practices; telephone, electronic mail, or text messaging; elder
10	persons and persons with disabilities; private actions
11	A. For purposes of this Section, the following definitions apply:
12	(1) "Electronic mail" means an electronic message that is transmitted
13	between two or more telecommunications devices, computers, or other electronic
14	devices capable of sending and receiving electronic messages with a person
15	identified by a unique electronic address.
16	(2) "Telephone" means a system for transmitting voices over a distance using
17	wire, radio, cellular, or electric signals.

1	(3) "Text messaging" means using a wireless telecommunications device to
2	manually communicate with any person by using a text-based communication
3	referred to as a text message, instant message, or direct message.
4	B. In addition to any damages to which a person is entitled pursuant to R.S.
5	51:1409, the court may award damages not to exceed ten thousand dollars per
6	violation to any elder person or person with a disability, as those terms are defined
7	in R.S. 51:1402, who suffers damage or injury as a result of an offense or violation
8	described in this Chapter through marketing by telephone, electronic mail, or text
9	messaging.

Abstract: Provides for heightened damages in a private right of action for unfair trade practices by telephone, electronic mail, or text messaging when the person who suffers loss is an elder person or a person with a disability.

<u>Present law</u> (R.S. 51:1405) prohibits unfair and deceptive acts or practices in the conduct of any trade or commerce.

<u>Present law</u> (R.S. 51:1409) creates a private right of action to recover damages sustained pursuant to unfair or deceptive acts or practices.

<u>Present law</u> (R.S. 51:1402) defines "elder person" as any person sixty-five years of age or older. <u>Present law</u> also defines "person with a disability" as a person with a mental, physical, or developmental disability that substantially impairs that person's ability to provide adequately for his own care or protection.

Proposed law retains present law.

<u>Proposed law</u> defines telephone to include cellular phones and further provides definitions for electronic mail and text messaging.

<u>Proposed law</u> provides for an increased potential for damages when the prohibited unfair or deceptive act was committed against an elder person or person with a disability using a telephone, electronic mail, or text messaging.
