Applicability 8 This Chapter shall not apply: 9 10 (45) To records, data, writings, accounts, reports, letters, exhibits, pictures, 11 photographs, drawings, charts, maps, or copies thereof, whether written or oral, 12 received from any person by the Department of Wildlife and Fisheries, which pertain 13 to or in any way involve information relative to activities associated with the egg 14 collection, stocking, captive breeding, or farming inventory of alligators, or shipment 15 of alligators or alligator skins domestically, nationally, or internationally; however, 16 aggregate, statistical reports that do not reveal, directly or by inference, the identity 17 of the individual source of the information compiled by the Department of Wildlife 18 and Fisheries may be released to the public by the secretary of the department.

Abstract: Exempts from the Public Records Law information relative to certain activities associated with the stocking and breeding of alligators.

<u>Present law</u> provides for an exemption from the Public Records Law information received by the Dept. of Wildlife and Fisheries related to shipment of alligator or alligator skins. Provides that aggregate statistical reports that do not reveal individual sources of information may be released to the public by the department.

<u>Proposed law</u> additionally exempts from the Public Records Law information related to activities associated with the egg collection, stocking, captive breeding, or farming inventory of alligators. Retains the ability for the department to release aggregate statistical reports that do not reveal individual sources of information.
