22	(10) The Sex Offender Registry Technology Fund created in Code of
23	Criminal Procedure Article 895.1 shall be renamed the Sex Offender Registry
24	Technology Dedicated Fund Account.
25	(11) The Youthful Offender Management Fund created in R.S. 15:921 shall
26	be renamed the Youthful Offender Management Dedicated Fund Account.
27	(B) The Louisiana State Law Institute is hereby directed, pursuant to its
28	authority in R.S. 24:253, to correct any reference in any Code or the Louisiana
29	Revised Statutes of 1950 to reflect the changes to the funds and accounts listed in
