JUDGES: (Constitutional Amendment) Provides relative to the holding of public office and public employment

A JOINT RESOLUTION

Proposing to amend Article V, Section 23 of the Constitution of Louisiana and to add Article X, Section 31 of the Constitution of Louisiana, relative to public office and public employment; to provide relative to the holding of public office or public employment; to provide relative to age; to provide for the elimination of the mandatory retirement age for judges; to provide for submission of the proposed amendments to the electors; and to provide for related matters.

Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members elected to each house concurring, that there shall be submitted to the electors of the state of Louisiana, for their approval or rejection in the manner provided by law, a proposal to amend Article V, Section 23 of the Constitution of Louisiana, to read as follows:

§23. Judges; Retirement

Section 23.(A) Retirement System. Within two years after the effective date of this constitution, the legislature shall provide for a retirement system for judges which shall apply to a judge taking office after the effective date of the law enacting the system and in which a judge in office at that time may elect to become a member, with credit for all prior years of judicial service and without contribution therefor. The retirement benefits and judicial service rights of a judge in office or retired on the effective date of this constitution shall not be diminished, nor shall the benefits to which a surviving spouse is entitled be reduced.

13	to the electors of the state of Louisiana at the statewide election to be held on October 12,

16	there shall be printed a proposition, upon which the electors of the state shall be permitted
17	to vote YES or NO, to amend the Constitution of Louisiana, which proposition shall read as

Abstract: Prohibits the denial of the right to hold public office or public employment based on age and provides for the removal of the mandatory retirement age for all judges.

ENGROSSED HB NO. 178

<u>Present constitution</u> requires that no judge may remain in office beyond his 70th birthday. This provision allows a judge to complete the current term if he attains 70 years of age while in office.

<u>Proposed constitutional amendment</u> repeals the mandatory retirement age of judges.

<u>Proposed constitutional amendment</u> provides that no person shall be denied the right to hold public office or public employment based solely on age.

Provides for submission of the proposed amendment to the voters at the statewide election to be held Oct. 12, 2019.

(Amends Article V, §23; Adds Article X, §31)
