 product under any of the following circumstances:

(a) When a person under eighteen twenty-one years of age is accompanied
 by a parent, spouse, or legal guardian twenty-one years of age or older.

(b) In private residences.

(c) When the tobacco product, alternative nicotine product, or vapor product
is handled during the course and scope of his employment and required in the
performance of such person's duties.
