1 A RESOLUTION

2 To designate Thursday, May 9, 2019, as FFA Day at the state capitol and to commend the
3 state officers of FFA.

4 WHEREAS, the National FFA Organization prepares and trains students for
5 leadership and professions in the science, business, and technology of agriculture in public
6 schools throughout our nation; and

7 WHEREAS, the mission of the FFA organization is to make a positive difference in
8 the lives of young people by developing their potential for premier leadership, personal
9 growth, and career success through agricultural education; and

10 WHEREAS, the motto of the FFA organization, "Learning to Do, Doing to Learn,
11 Earning to Live, Living to Serve", gives members words to live by as they experience the
12 opportunities of the organization; and

13 WHEREAS, the National FFA Organization consists of more than six hundred
14 seventy thousand members in the United States, Puerto Rico, and the Virgin Islands; and

15 WHEREAS, FFA membership in Louisiana continues to be strong and includes
16 nearly eleven thousand agricultural students in one hundred ninety-nine chapters throughout
17 the state; and

18 WHEREAS, the members of the Louisiana House of Representatives recognize the
19 importance of agriculture to the economy of this state, as well as the importance of the
20 education and training students in the state receive through agricultural education programs
21 that develop competent and assertive agricultural leadership.

1 THEREFORE, BE IT RESOLVED that the House of Representatives of the
2 Legislature of Louisiana does hereby designate Thursday, May 9, 2019, as FFA Day at the
3 state capitol.

4 BE IT FURTHER RESOLVED that the House of Representatives of the Legislature
5 of Louisiana also recognizes and commends the 2018-2019 state FFA officers as follows:
